We may need to be the impetus for these steps to invigorate the quarterly meeting. Southern Quarter meets in May at Wicomico Monthly Meeting. Maryland Quaker Voice may be something to share there as well.

### **Communications Annual Report – Marie Leonard for John Hawkinson Accepted**



This year we have added Beth Mufson as our official Photographer. Our next most recent member, Amy Owsley keeps us up to date on the First Day school. Marie Leonard, plans to publish a new Meeting Directory with current updates. Tatiana Harrison sustains the website, Dee Rein monitors the meeting's telephone messages and prepares the newsletter, John Hawkinson responds to the meeting's e-mail messages as well as sending out announcements and newsletters.

### **Facilities Use Annual Report - Larissa Kitenko Accepted**



Third Haven Friends Meeting continues to provide a quiet, reflective space for the Meeting's activities, Members' outside activities as well as the meetings of non-members.

Detailed data on usage and the 2017 approved donation and fee structure policies are available on the Third Haven website.

In 2019 368 meetings took place and donations for usage were \$4734.

#### **2 - Scheduling on the Paper Calendar/Syncing with On-Line Calendar**

Members are notifying Facilities Committee for the majority of requests of dates/times for meetings, Weddings or Memorials either by contacting Larissa Kitenko (e-mail/text) or Adrienne Rudge.

Non-members typically leave a voice message on Third Haven's answering machine or contact the website administrator. Interestingly, non-members use our on-line calendar to decide when to schedule an event. All phone requests are forwarded by Communications Committee to Larissa. There is frequent communication between Facilities and Communications Committees.

#### **3 - Appropriateness of facility fees**

The current system of categorizing meeting/event types seems to be working well.

#### **4 – Donations**

Donations are forwarded by the Facilities Comm or Friendly Presence to our Treasurer in a timely manner along with a clear description of the event and its date and time. There is frequent communication between Facilities Committee and the Treasurer regarding upcoming events and their expected donations.

### **RECOMMENDATIONS:**

1 – Members to continue checking the Common Room Calendar and notifying Facilities Committee of desired dates/times for their event.

This will:

- inform the Committee
- prevent double-bookings
- insure a Friendly Presence at each event
- collect & record donations in a timely manner
- insure clean-up

2 - Continue the current donation schedule.

3 – Continue communications among Treasurer, Facilities and Communications Committees as well as other committees s needed.

Comments: An increase in activity was noted. We are currently working around the space we have to accommodate activities. Our planning process will consider the nature of our needs. Young families need safe space for enhanced programs, which are now limited by current space.

#### **FDS Update- Amy Owsley & Susan Claggett Approved**

Little Spices is up and running for spring for 6 Fridays with 14 children attending including new families. The topics are Quaker SPICES (Simplicity, Peace, Integrity, Community, Equality, and Stewardship). All families were interested in information about Third Haven.

Summer camp sessions beginning June 29 and July 7 are planned and will be advertised for ages 5-12.

First Day School divided up today with different topics for different age groups. We are working to have relevant topics for older children.

Proposed is partner collaboration with Peach Blossom Learning Group for older children. This is First Day School outreach with aid from Peach Blossom, which has liability insurance and paperwork processing ability. The program will focus on our queries on Friday mornings September- May in 6 week sessions, from 9a.m.-12 for 5 sessions, ages 5-14 in two age groups on the grounds and in the Common Room for school year 2020-2021 with 12-20 children. Emphasis will be on science, art, health and wellness. A query on betterment of the community will provide a project for each session. The program will be budget neutral and cover expenses for the Meeting.

### **Planning Committee Update- Ben Tilghman**



4 responses from architects have returned from 7-8 solicitations. Now we are trying to whittle that down, keeping in consideration previous exposure to Quaker values. 3 firms have visited the site. All 4 will be invited for a charrette (a meeting of 4 hours each with high powered, detailed presentations with initial visualizations, drawings or models.) Meeting members may attend. The committee will provide preliminary background information. Suggested is a stipend of \$1200 per firm to cover costs and add an arms length quality to the transaction. Requested: \$5000 to support the vetting process for executing the long range plan. Cash reserves outside our budget exist to cover this. The future planning fee will be somewhere from \$10-

20,000 for a master plan in the future. A member suggested donations of \$100 to support this purpose. **\$5000 from current funds-Approved**

### **Testimonies and Concerns committee update- Paige Tilghman Accepted**



The Climate Reality Project, hosted at THM on February 20, featured speaker, Bob Ellis, Philadelphia Climate Reality Project, who provided an overview of current climate conditions worldwide and the impact new technology is having on energy generation and consumption. The evening attracted over 60 participants from the wider community. Dona Source and Mary Yancey gathered email addresses for continued correspondence and news from the CCAM, a statewide advocacy group that seeks to impact change. The activity is prorated through the T&C Committee at this time as part of the committees interest in impacting climate change locally.

The T&C Committee recommends a total of \$300 of funds from the Schoffner International Education Fund for disbursement (\$150.00 each) to the Bolivia Quaker Education Fund and the Patajmos School in Guatemala. The Friends Fiduciary reports (December 2019) the Schoffner International Education Fund had a Market Value of \$19,476.07 and a Cash Value of \$14,622.81. T&C makes this modest distribution in keeping with a goal to grow the Cash Value of the fund to \$20,000 to provide interest in come for distribution.

T&C reminds members that the 2019 Giving Guide, (to be distributed again with

announcements), was distributed in December, as a guide for charitable donations. The Giving Guide was organized around the PYM Queries to encourage charitable in keeping with our Query considerations. In addition to this reminder of charitable giving, we would like to recommend a consideration of contributions to the Quaker United Nations Office

to direct funds and resources to central Africa being impacted by the Locust blight and sure to require additional food this summer. Members are currently involved in immigration work.

### **Carbon Footprint Off-set**

“Dear Friends at THMM, At Molly’s request I’m sending to the newsletter an innovative, uniquely Quaker way to off-set our carbon-footprint. Several Meetings in New England YM follow this. <https://www.mounttobyfriends.org/action/voluntary-carbon-tax-witness/> Meetings offer support to those of their members who are believed to be undertaking a spirit-led witness. A small group of Quakers in Cambridge, MA have come together to gain knowledge about our individual carbon footprints, and to calculate a related “carbon tax” on ourselves. We hope to raise awareness in making this calculation and garner more carbon offset contribution.

As a group we decide four times per year a non-profit organization to which to make our contributions. The amount for each witness is confidential and known only by the treasurer. This quarter we decided to focus on the removal

of plastic from the oceans, and after some research have chosen to give our \$600 to Ocean Cleanup North Pacific Foundation. Other groups have been NE Grassroots Environment Fund, One Tree Planted, and Mothers Out Front.

The climate calculator is created by Stephen C. Gates, a Quaker from Cape Cod Members of Quaker Meetings in New England learn how to use the calculator—
