Third Haven Friends Meeting Meeting for Business 1st Month, 14th, 2024

Opening silent worship: Clerk Tom Corl opened the Meeting with silent worship at 11:36 a.m.

Approval of minutes for 12th Month 10th meeting for business Approved

Clerk's items – Tom Corl

Sam Steffens was welcomed into membership by the welcoming committee. She is an active member of the reading the gospels group and committees.

Treasurer's report – *Bill Lane for Ben Tilghman* Currently we have \$90,500 in Operating cash, and \$184,000 in the building fund. Our liabilities against our cash

consist of our credit card monthly bill, and 4th quarter payroll taxes of approximately \$1,000.

With a little over 50% of the budgeted year behind us our operating expenses (\$48,700) are at 67% of budget, with operating income (\$37,600) at 52% of FY 23-24 budget. Member contributions (\$30,375) are at 55% of budget of \$55,250. Donations tend to increase in December as friends adjust their taxable donations; it's not surprising that donations are running a bit ahead of budget.

Expenses are consistent with past activity in that we made our Covenant payment to PYM early, in December, even though it's due in January, and expended our entire charitable donations budget of \$3,000 in December. If we remove those expenses from our year to date, our percentage of expenses to budget becomes 58% with 50% of the year past. We are still spending more than we are bringing in in operational funds. At this point in the year, we need not be overly concerned with the shortfall as long as we recognize that supporting the Operating budget must not be taken for granted.

In addition to ongoing efforts to reach out and maintain regular communication and support with individual members and attenders, the Pastoral Care Committee engaged in the following activities during 2023:

- Coordinated transfer of membership for Sam Steffens,
- Annual and regular updates to the directory of members and attenders,
- Provided support for members experiencing emotional and or financial distress,
- Revised name tags and created new name tags for new attenders.
- Purchased and distributed Advent Calendars for First Day School families,
- Hosted annual members and attenders lunch,
- Developed and hosted Aging as Friends series.

Comments: Thanks were offered to Dona for her service as clerk. Friendly Eights are being discussed to return this year.

Planning Committee update – *Tom Corl*

The Planning Committee (PC)met on 1.10.24 and <u>decided</u> that we want:

- No roof over the south side doorway on the BMH, and
- To restore the windows in the transoms above the north and south side doors. We do not know what is behind the present covers. This is likely to be favorably viewed by the Historic District Commission

The PC plans to identify several contractors and interview each. The potential contractors are: ER Harvey Metalworking Company, Easton, may be able to fabricate the stairway; Bruce Harrington Construction, Easton; Harper and Son construction, Easton; Frank E Daffin Inc, Easton; and Willow Construction, Easton.

When we have complete building drawings, we can contact these companies and begin to arrange interviews. Contractors will be able to give us cost estimates. We plan to

arrange preliminary meetings with the Easton building department and the Historic District Commission (HDC) before going for permits with a contractor.

The PC will develop and <u>integrate</u> the renovation plan for the 2nd floor of the BMH for First Day School (FDS), to include the 1st and 2nd floor bathrooms. Susan Claggett will convene a meeting of FDS parents and the PC to walk through the 2nd floor of the BMH and develop a plan for 2nd floor renovations.

Outreach Committee update – *Nancy Robbins*

Question: Outreach is talking about having speakers come in and inviting the community as we have in the past. What topics are suggested? Perhaps we could have the local Rabbi and Imam come to hear from their perspectives. What format is preferred?

Art Show and sale update – *Marie Leonard*

We had a good turnout with 16 different artists and raised \$1124 for Third Haven. The funds go toward renovations via the building fund.

New business

Comment: Hearing the Meeting for Worship with Attention to Business reports shows how we put our faith into action using our property. We use our facilities to reach the community.

Nancy Robbins asked if an open mike poetry group which floats locations may use our space. Nancy Robbins could serve as a Friendly Presence. Referred to Facilities Use Committee.

Memorial Intentions

Third Haven's Pastoral Care Committee invites you to complete the Memorial Intentions form found below, as well as attached for easy printing, and return it to a Pastoral Care Committee member.

Third Haven Friends Meeting Memorial Intentions

Instructions

Friends are reminded to "make provisions for the settlement of all outward affairs, while in health so that others may not be burdened and so that one may be freed to live more fully in the Truth." See *Faith and Practice*, 2018, pp 219-222. Each Friend has the responsibility to settle outward affairs, in good order, and make clear his or her memorial intentions and directions, so as to lighten the burden on family and Friends, at the time of her or his death.

This Memorial Intentions form is intended to help Third Haven Friends Meeting and your designated Personal Representative carry out your intentions and directions at the time of your death, with regard to a memorial service, under the care of the Meeting, burial, grave marker, plaque and any other of your intentions and directions. As of December 31, 2019, Third Haven Friends Meeting will no longer allow casket burials in the Meeting Burial Grounds.

This form can be a great help to those who will miss us when we are gone. A member of the Pastoral Care Committee can help you through the process of completing this form, as well as identifying sites for burial site, grave marker and/or plaque in the Meeting burial grounds.

This form is available on the Meeting website in the Pastoral Care/ Declaration of Intentions section as a Microsoft Word file, which can be drafted, revised and edited on a

personal computer. If you are computer-free, a member of your family or a friend may be able to assist you.

In addition to completing your Memorial Intentions, the Meeting recommends that Friends complete a will, <u>Advance Medical Directives or 5 Wishes, Financial and Medical Power of Attorney</u>. You can consult with a lawyer, Talbot Hospice, Brookletts Place (The Talbot County Senior Center), or other agencies or resources about your estate planning.

When you have completed your Memorial Intentions, retain paper and electronic copies for yourself and your designated Personal Representative, and return a paper copy to the Pastoral Care Committee, to be retained in the Memorial Intentions records for members and attenders of the Meeting.

If yes, what is the grave site designation?

Grave Marker

If you intend to be buried in the Third Haven burial grounds, it is customary to have a grave marker installed at your burial site. Grave markers must be keeping with the Quaker testimony on Simplicity – of a size, scale, form and composition that is consistent with the existing historic grave markers present in the burial grounds. Your Personal Representative needs to secure the approval of the Burial Committee for the grave marker prior to its being installed.

Memorial Plaque Do you intend to have a memorial plaque installed on the brick wall adjacent to the Third Haven burial grounds (yes or no)?

Have you selected a specific plaque site, in consultation with the clerk or another member of the Pastoral Care Committee (yes or no)?

Have you recorded your selected plaque site with the Pastoral care Committee and the Burial Ground Archivist (yes or no)?

Your Personal Representative needs to secure the approval of the Burial Committee for your plaque prior to its being installed.

Memorial Service at Third Haven Friends Meeting

If you want to have a memorial meeting for worship, at Third Haven Friends Meeting, under the care of the Meeting, describe your memorial service intentions and directions. Describe all specific requests for your memorial service, such as readings, speakers, flowers, financial donations, and other such requests. Provide as much detail as you want.

Conclusion

Whether or not these Memorial Intentions statements are legally binding on Third Haven Friends Meeting, I expect that Pastoral Care Committee and Third Haven Friends will try to help fulfill these Memorial Intentions and directions. Third Haven shall act as a depository and advisor for the fulfillment of my Memorial Intentions at the time of my death. I execute this document for the purpose of guiding my Personal Representative(s), family, the Meeting, Friends and friends at the time of my death.
