Spiritual State of the Meeting Report -Dona Sorce

The Philadelphia Yearly Meeting Worship and Care Committee is composed of people from all PYM mtgs. This committee reviewed reports from all of the meetings, summarized and identified 3 concerns: 1. Pastoral Care-how to provide intergenerational care in declining memberships with mental health, substance and chronic needs. PYM will offer thread sessions to help meeting broaden their scope. 2. First Day School-how to support FDS for children and make it an intergenerational sharing of programs, also engaging with young families to facilitate their participation. 3. Worship and Ministry- in reach and outreach- how to let the community know who we are and what we do, drawing people from the community to the Meeting for existing events. PYM is seeking \$30,000 to get a Pastoral Care matching grant. Please donate.

Treasurer's Report – Ben Tilghman-

With approximately 40% of the fiscal year completed, income stands at 30%, while expenses are at 34% when compared to the FY22-23 budget. This is consistent with past years,

Friends are reminded that they might consider making donations in December to take advantage of the 2022 IRS tax year. Donations to the Annual Operating Budget of the Meeting and to the Meeting Building Fund are both deductible under IRS regulations. Please make note on your checks of the fund to which you wish the donation to be applied, and, if at all possible, provide a separate check for each fund.

As we look to the rest of the fiscal year, please remember that grant applications almost universally look for a demonstration of support within the requesting organization, usually expressed as a percentage of donors to members. 100% participation is ideal; the amount donated by each member is not considered relevant and is never disclosed.

Responding to a question, it was noted that our covenant to Philadelphia Yearly Meeting is \$17, 500 annually. No recommendation for individual members donating to Third Haven.

Signing this pledge is a public statement that we support the goals and ideals of IPC, that we are a like-minded organization. The Campaign (fundraising) Committee will meet on Saturday 12.17, 9:30 - 11:00 am, in the common room and on Zoom. Friends are encouraged to attend in person. At the first 11.19 meeting committee discussed the name of the committee, the name of the campaign and tag line for the campaign, and considered an overall financial goal. At the first meeting, the committee formed several working groups to carry out the Meeting fundraising campaign.

The Meeting Support group will reach out to members and attenders, asking them to contribute to both the Meeting's annual operating budget and the Meeting Building Fund. The goal is to increase the giving rate to the Meeting from 50% to something closer to 100%. Friends should give what they can. The amount is not important. The giving rate will be very important to securing grants and getting financial contributions from outside the Meeting community.

Testimonies & Concerns: – *Paige Tilghman*

Testimonies & Concerns recommends Charitable Contributions to our 12th month Meeting for Business. T&C met 11th month to review the organizations that support our local and wider communities as viable considerations. We are especially concerned about the shortage of available and affordable housing, our focus off effort for this year's committee work. We are also concerned about those misplaced and in need of shelter and food in Ukraine. We believe anything we can contribute to the Ukraine people at this time is significant. The Charitable Contribution budget is \$3,000 for distribution. We submit the following recommendations: \$500, \$500 Talbot Interfaith Shelter (TIS), \$500 to Chesapeake Multicultural Center, \$1,000 to Ukraine relief (International Red Cross and Red Crescent Federation as a suggestion) **Donations Approved** The 2023 Giving Guide has been updated and is included for your consideration and guidance. Copies will be circulated attached to announcements. Also of note: The Talbot County Detention Center Library Committee has requested \$150 to upgrade software to maintain the rental of books at the Detention Center. **Approved.** New volunteers are always welcome but training is required.

T&C invites Meeting to the Common Room on Saturday, December 17th at 3 pm to prepare and deliver a dinner for 16 occupants at the TIS. All the ingredients for a spaghetti dinner have been donated. All are welcome to help us cook and deliver the dinner.

Art sale report – Marie Leonard

Thanks to everyone involved who helped, visited or participated in the Art Show & Sale that took place on a rainy Saturday, December 3rd, from 11am to 3pm. Ten Third Haven Friends Meeting affiliated artists displayed their artwork & crafts, as well as the First Day School and a Bake Sale table. Artwork included paintings, prints, glasswork, baskets, photography, knit items, jewelry, holiday gifts and baked goods. Artists were able to donate an average of 56% of their sales which will help fund the renovation of Third Haven's historic buildings and grounds. Despite the rain, there were approximately 83 attendees and more than 20 visited the meetinghouse(s) to learn more. The total amount donated to Third Haven from this event was \$1,023.

Adrienne Wheeler Rudge, a resident of Easton, Maryland, died on Saturday, December 10, 2022. She was 80.

Adrienne was born on December 15, 1941 to Betty Jean Hammond and Charles Elliot Wheeler. She grew up on her family's waterfront farm on Trippe Creek in Easton and graduated from The Country School, George School in Newtown, Pa., and in 1963 from Wheaton College in Norton, Mass. She received a master's degree from the New York University School of Education.

After a year of teaching English at Dana Hall School in Wellesley, Mass., Adrienne married Kit Rudge, and they moved to New York City in August 1964. She joined the faculty of Nightingale Bamford School while he practiced law. They moved to Chappaqua, NY, in 1975 where they raised their two sons, John and Andrew.

While living in Chappaqua, Adrienne served on the boards of several non-profit organizations. Retiring in 2001, she moved to Easton, where she built a home on her family's farm. Her involvement in the local community has included board membership at Talbot Hospice and Critchlow Adkins Children's Centers. She enjoyed her participation in the Garden Club of the Eastern Shore and her membership in The Harbor Club, where she had a regular Friday afternoon bridge game with good friends. She was an active member and a trustee of Third Haven Friends Meeting. During her retirement, she enjoyed traveling both nationally and internationally. She returned to New York City frequently to visit friends and family and to enjoy the theater and visits to the many museums in Manhattan.

Adrienne is survived by her son John Rudge of White Plains, NY, her son Andrew Rudge and her daughter-in-law Shelley Jones Rudge of Chevy Chase, Md., by her sisters Lindsley Smith and Susan Wheeler, both of Easton, her brother Charles Wheeler of Berkeley, Calif., and by her four grandchildren: Charlie, Elizabeth, Avery and Kate Rudge. Kit Rudge died in 1995.

A memorial service will be held at Third Haven Friends Meeting at 405 South Washington Street in Easton in spring 2023 (date and time to follow).
