Third Haven Friends Meeting Meeting for Business 5th Month, 14th 2023

Opening silent worship led by Clerk Dee Rein began at 11:40 a.m.

The 5th Query was read aloud.

Approval of minutes of the 4th month 16th meeting for business: APPROVED

Budget & Finance Committee: presentation of initial proposed budget for FY 2023 - 24 - Bill*Lane and Ben Tilghman* (report spreadsheet may be seen on our website) With 83% of the fiscal year behind us, income is only at 76%, or roughly \$5,000 under budget. Additionally, expenses are at 88%, or roughly \$4,000 over budget. It almost goes without saying that this is not a sustainable trend. It is important to note, however, that the overage in expenses is driven largely by one substantial expenditure in Property and Grounds of slightly over \$5,000 for driveway maintenance. With the heating season behind us, while we still project overall expenses in excess of budget it will considerably less than the current \$4,000 overage.

Income is another matter. A large proportion of the shortfall is in donations from attenders, which are at 65% of budget. Members donations are higher at 73% of budget, Overall, we are projecting no surplus, and actually are looking at a shortfall of \$4,000 for FY22-23's operating budget.

The FY 23-24 projected budget is currently projecting a deficit of \$9,500. As mentioned, budgeting is an iterative process, and as of the time of this report, we still had yet to hear from some of the Clerks regarding their committees' planned expenses. We still have time to rework the budget, but will have to make some hard decisions regarding our projected expenditures for next year if we cannot assure ourselves of adequate income.

Planning Committee: presentation and discussion of the proposed Master Plan – *Tom Corl* The committee will have its own budget in the coming year rather than using monies drawn from the general budget.

- Slides: The testimonies were presented as undergirding the architects' plan. Then the site and concept slides were shown. The selected concept called the Lawn was shown. This led to the Master Plan slide, its details shown on subsequent slides. Diagrams were also handed out for individual inspection. Slides illustrating vegetation, vehicular routing, walkways, tree removal, elevation and other visualizations, and ideas for phasing and priorities were shown. Additional options for floor plans were shown. No ideas are fixed; they are representative possibilities.

- Items discussed: parking spots and capacity; concerns about expenditure of money; perceived needs underlying the concept of planning in general such as enlarged and updated spaces; possible restraints on changes to historic structures; geothermal and solar energy possibilities; concerns about breaking through the brick wall to access Trippe Avenue; appreciation for the planners and the process, particularly regarding safety and accessibility; public use of the property; and thoughts regarding priorities agreed to by the Meeting. The spirit of and gratitude for the property, particularly as a place for children and community, was expressed. The storage shed was presented as an obstacle to visualizing the plan; there was support in favor of moving it imminently. Growth of the Meeting and ongoing expenses were themes of concern.

Acknowledging concerns regarding growth of the Meeting, financial issues and specific aspects of the Plan to be decided later, the REPORT was ACCEPTED.

Trustees' annual report – *Priscilla Sener*

Seventy-five years ago, the members of our meeting incorporated a new entity called The Trustees of Third Haven Monthly Meeting of the Society of Friends, Incorporated. Our monthly meeting subsequently deeded the real property of Third Haven to the new nonprofit corporation in November, 1949. One factor that influenced their decision was the possibility that the monthly meeting might have to be "laid down," in which case our meetinghouses and burial grounds would be transferred to Philadelphia Yearly Meeting. Third Haven members considered local ownership and stewardship essential to the continued survival of these historically significant treasures.

Funding for the Trustees has come from donations, legacy gifts and from the growth of investments which could be characterized as an endowment. The Trustees support capital projects, large and small. In the 1980's, construction of the Common Room was partially funded by the Trustees, and in the 1990's a major restoration of the Old Meeting House was supported by nearly \$450,000 of Trustee Funds.

Since 2021, under the leadership of Bill Lane, the Trustees have been working on another major round of repairs necessitated by the chronic issues of rising damp. Architectural Historian Carl Lounsbury surveyed Friends' records and reports that the need for moisture mitigation has recurred on average every thirty years beginning in 1698. Technologies improve. The current round is aided by laser scans, dendrochronology, and continuous digital moisture readings. To date, the trustees have spent \$88,000 on the project. An additional \$142,000 is needed to complete the work. We have received contingent approval from the Maryland Historical Trust easement committee and we project completion in 9-12 months.

Current Trustees are Larny Claggett, Marsie Hawkinson, Bill Lane, Marie Leonard, Allan Mielke, Dee Rein, and Priscilla Sener. We continue to mourn the loss of past president Adrienne Rudge. We are guided by her clear and kindhearted ability to get to the heart of matters. Quoting from Adrienne's 2022 report to Meeting for Business:

"I urge all members and attenders to support the preservation work of the Trustees of Third Haven Monthly Meeting by making an outright gift or by designating a legacy gift in their estate plans."

This report is given for the information of the Meeting each year and requires no action.

-Presented was a letter from Carl Lounsbury from Colonial Williamsburg highlighting the historical and architectural significance of Third Haven and its property. This letter was written in support of a grant request and will be published at a later date. In nine months to a year the work on the Old Meetinghouse will be finished. REPORT ACCEPTED.
