## **Third Haven Friends Meeting: Minutes of the 10th Month 10th, 2004 Meeting for Business**

Redick, Anne Rouse, John Schreiner, Karen Stoker, Norval Thompson, Ann Williams, and Winslow Womack. Clerk of Meeting, Marsie Hawkinson, conducted the

meeting for business following a period of silent worship.

**Query for Tenth Month** – The query was read during meeting for worship. The Clerk asked for additional reflections. A friend shared joy in the summer Quaker earth stewardship camp held at Third Haven and the description of it recently published in the newsletter. Another friend queried: what does war do to the environment? Friends commented on the Nobel committee's recent nominations as an acknowledgment of the role the environment plays in peace.

**Approval of Minutes** – After discussion and clarification, the minutes of the 9th Month 2004 Meeting for Business were approved with no changes.

**Clerk's Correspondence** – The Clerk read a letter from Wicomico River Meeting of transfer of membership for Leonard Baynham. Friends welcome Leonard back into membership at Third

Haven with joy. Marsie also noted receipt of a post card from Tom Corl mailed to Third Haven during his European travels. The Clerk had a request to release our membership list to the Earlham School of Religion, to enable them to distribute information about the school. This request was declined, citing friends' concerns about unsolicited bulk mailings and a general reluctance to share the mailing list

**Treasurer's Report.** During 9th Month 2004, the meeting had income of \$2624.40 and paid expenses of \$4797.11, the latter including a payment of \$2300.00 to Claiborne Builders for repair of the entryways to the brick meetinghouse. Fiscal year-to-date income is \$4525.51 and expenses \$11,586.03. The only unusual expense thus far this fiscal year is the aforementioned repair item; it is expected that the meeting Trustees will reimburse the meeting for this expense. Budget & Finance committee clerk Larny Claggett said that financial assistance from the Trustees may be available for repairs such as these, but emphasized that there is no rule for how assistance is administered, so the meeting should not expect assistance for every repair. Friends approved the report, with thanks to Joe Davis for his work on our behalf.

**Library & Outreach Committee Annual report** by Anne Rouse. Two dozen books from the meeting library have been donated to the Talbot County Public Library for inclusion in the Quaker section of the Maryland Room. The shelf space freed by this donation makes use of our current collection easier. The committee thanks Bill Lane for his donation of books. Ken Carroll notes that he will be requesting the library look through his personal collections for items of interest. Friends are reminded to place their copies of Friends Journal at their local library when they have finished with them. We may wish to ask the committee to

consider listing Third Haven's library titles on the meeting web site. Friends approved the report.

#### **Property & Grounds Committee**

Clerk John Schreiner presented the committee's annual report, highlighting repairs to the roof of the old meetinghouse, entryway and door repair, crack repair, and pointing on the brick meetinghouse, painting of Annie's Cottage, improved drainage along the entryway, bush-hogging of the back field, and a new effort to plot existing trees and major plantings. The committee accomplished all of this work at nearly 6% under budget. A copy of the report is attached to these minutes. A friend noted that the new paint on Annie's Cottage improves the beauty of the entry. Another friend asked about the future of a crape myrtle placed where friends tend to gather to socialize after worship. John indicated that the crape myrtle would be moved and encouraged friends to contact the committee for assistance in locating new plantings on the meeting property. A friend asked whether an undesignated bequest would accrue to the Trustees or to the meeting budget. It was recommended, regarding financial contributions, that friends specify whether they wish to donate to the general meeting budget or to the Trustees' Fund. One option may be to add this information to the meeting's form that solicits friends' wishes at the time death. The meeting approved the report, with great thanks to John and the entire committee for their hard work on behalf of the meeting.

**Overseer Committee** - Nancy Mullen will be making a poster for the common room that will list friends' birthdays. Friends wishing to contribute to a fund established for Ginger Howell may do so through treasurer Joe Davis; please specify "Howell Family Fund" with your contribution. Paige Bethke reported that the joint meeting of Overseers and Worship &

Ministry committees had been a fruitful mix of the unbridled energy Overseers and the Quakerly conduct of Worship & Ministry. She notes that the two committees can learn much from each other.

#### **Worship & Ministry Committee**

Committee clerk Bob Marshall reported that the major topic of the joint meeting with Overseers had been developing ideas for adult education and discussion. The committees propose that a block of time at rise of meeting on the last First Day of every month be devoted to an adult education session. A facilitated discussion format is envisioned, with emphasis on spiritual discovery and discernment. Readings may be suggested ahead of time. A break following meeting for worship is anticipated so that parents may check on children. Childcare and lunch for the children will be provided. Friends APPROVED this general approach. A friend wondered if topics would be set out for the year, to allow planning; other friends shared concern that our meeting not become overly programmed. Another friend queried about gathering before meeting for worship, and Bob shared that attendance at sessions scheduled for that time has historically been less than for those scheduled to follow meeting for worship.

**First Day School Committee** report by Susan Claggett. The current curriculum is Truth in Action, focusing on truth telling and unity. Five thousand dollars of the proceeds from the carriage shed sale have been donated to Heifer International. Of the remaining monies, \$400.00 was used to purchase a large-screen television for the common room, and it is suggested that the balance be allocated for construction of a play yard for the children. The clerk said that the remainder of the carriage shed sale money is around \$800.00. Friends approved allocating this money for a play yard. Property & Grounds committee will be

consulted for input regarding location and maintenance. Helen Fields from the religious education staff at Philadelphia Yearly Meeting will be at Third Haven on 11th Month 7th to facilitate training on “Godly Play.” Finally, Marsie informed friends that Dan Chaudoin has agreed to look into the risk management issues raised previously.

**Nominating Committee** clerk Mary Cotton reminded friends that this is the time of year for the nominations process. Committee memberships are generally three-year commitments, and clerkships two-year commitments. The committee will be contacting those individuals completing the third year of committee service, as well as working with the committee clerks to address needed adjustments to overall size or composition. Mary anticipates publishing the database of “terms” of assignment in the newsletter so that friends may verify the accuracy of their committee memberships and years of service. She notes that the clerk’s “terms” are mostly missing from the records, and asks that clerks contact her with the beginning year of their clerkship. This time of review is also a useful time for the meeting to propose any new committees necessary for the good conduct of our business.

Ann Williams reminded friends, on behalf of the **Hospitality Committee**, that if you use it, you need to wash it, dry it, and put it away, please.

Susan Claggett and Lorraine Claggett were named Southern Quarterly Meeting delegates.

Irene Williams’ daughter-in-law Barbara Williams remains in care in Salisbury following her car accident and will transition to home as she is able.

**New Business** – Norval Thompson reported that the Friends General Conference (FGC) executive committee would like to meet at Third Haven for one of

their regular quarterly meetings, in January or February 2005. Friends were open to this possibility and encouraged Norval to explore dates and expected number of participants. Hosting such a gathering might provide opportunity for a formal presentation from FGC. Susan Leibman shared that Atticus has required additional treatments for infection in his lungs, but is otherwise doing well, and thanked friends for holding him in the Light. A friend requested that we specifically ask visitors to speak loudly enough for everyone to hear, and that we are all careful to do this during meeting for business as well.



## Friends General Conference (FGC)



October 24th–27th 157 representatives from Yearly Meetings met in New Windsor Maryland to conduct the annual Business Meeting as the FGC Central Committee. The decision was approved to take the next 12 month to discern best use of a \$1.2MM Bequest . It was also approved to take \$60M from interest income to start pilot programs for young Friends.

**Minute on LGBTQ Friends** After much discernment the Following statement re: "our experience of and with lesbian, gay, bisexual, transgender, and queer (LGBTQ) Friends" was also approved and Minuted

**-Our Experience has been that spiritual gifts are not distributed with regard to sexual orientation or gender identity.**

**Our experience has been that our Gatherings and Central Committee work have been immeasurably enriched over the years by the full participation and Spirit-guided leadership of gay, lesbian, bisexual, transgender, and queer Friends. We will never go back to silencing those**

**voices or suppressing those gifts. Our experience confirms that we are all equal before God, as God made us, and we feel blessed to be engaged in the work of FGC together.--**

**-- The Friend General Conference Development Committee** plans to visit Third Haven in January. It meets four times a year, including Central Committee. Clerk Byron Sandford states “we are hosted by different monthly meetings. This year we have been the recipients of the gracious hospitality of Goshen Friends Meeting in Philadelphia Yearly Meeting, Heartland Friends Meeting of Great Plains and Missouri Valley Yearly Meetings and Martha’s Vineyard Worship Group in New England Yearly Meeting. We start each meeting with an evening of worship and spiritual sharing.” The committee sees two large areas of impact: We need to strengthen communication with our constituencies. This will include, among other things, developing a Comprehensive Communications Plan. .... We realize the Nurturing Quakerism campaign was FGC’s first real campaign, so there is no established pattern. There is now a new FGC brochure, ... for current Friends, and not intended to interpret Quakerism to others. A Monthly Meeting Contact project was started. The program now includes about 100 contacts. The office has been recruiting Contacts first from the smaller Yearly Meetings and has not yet done Philadelphia YM (the largest FGC yearly meeting).

## Philadelphia Yearly Meeting Interim

**Meeting** 24 April 2003 - Arch Street Meetinghouse, Summary of Minutes

**Minute # 1.** Worship and Opening Exercises. The meeting settled into worship at 6:00 p.m. The clerk welcomed 2 new alternates, 1 substitute, and 8 guests.

**Minute # 2.** New Business

(2.A.) The Role of an Interim Meeting Member. Friends lifted up challenges of being representatives  
2.B. General Secretary

(2.B.1) Report of Thom Jeavons’ Annual Evaluation The Review Committee reported strengths and challenges of the General Secretary.

(2.B.2.) **General Secretary’s Report.** Thom starts this year feeling hopeful about our present and future.  
(2.C.) Group to Review Yearly Meeting Donations to Outside Organizations. Friends approved appointing a committee to conduct this annual review.

**Minute # 3.** Continuing Business

(3.A.) An Additional Priority for our Yearly Meeting A fourth working priority was approved for our Yearly Meeting, that of “Supporting our Meeting Communities in expanding their spiritual lives.”

(3.B.) General Discussion of Unrestricted and Designated Funds TylaAnn Burger, Yearly Meeting Treasurer, and Kathy Reilly, Staff Director for financial matters, made a general presentation on Unrestricted and Designated Funds, with helpful graphics. Each year we give away 2.4 million dollars in interest income, and use another 2.9 million for our own expenses.

**Minute # 4** Nominating Committee Susan Makler, clerk, reported 8 nominations and 5 resignations.

**Minute # 5.** Business of the Standing Committees  
(5. A.) Education Standing Committee Jack Mahon, a member, brought the report of that committee on the request from the Greenwood Friends School for Yearly Meeting to help fund their new addition. and Millville Monthly Meeting, asking for a grant of \$148,990 to be used in completing a new wing of the school.

They did recommend that we take any special action.  
(5.B.) General Services Standing Committee Patsy Hunt, clerk, reported.

(5.B.1.) Annual Fund. The Annual Fund last year raised \$463,000, beyond our goal of \$435,000.

(5.B.2) Granting Groups. Written reports from the Bequests and the Chace Granting Groups were distributed.

Bequests last year approved 57 grants totaling \$348,230, while in the 6 months ending in May Bequests approved 12 grants totaling \$162,079.

(5.B.3) Friends Center Renovation and Future of Arch Street Meetinghouse. Work continues.

(5.B.4 ) Job Descriptions. Could we have job descriptions for our volunteers in PYM?

**Minute # 6.** Clerk's Correspondence.

(6.A.) Literature from the Bush / Cheney Campaign. The clerk received mailings from Committee to Reelect Bush / Cheney, the only response to our Minutes sent to the White House over the last four years.

(6.B.) Return Travel Minutes for Mickey Edgerton were received from North Carolina Yearly Meeting

(Conservative) and from North Pacific Yearly Meeting.

**Minute # 7.** Minutes of 24 June 2004 were corrected and approved.

**Minute # 8.** Announcements and Adjournment The PYM Budget Conference would be held at Arch Street Meetinghouse November 13 from 8:30 am to 1 pm.

AFSC and others are encouraging Candlelight Vigils on the eve of Election Day.

The "Safety and Insurance Conference" will be held at Arch Street Meetinghouse on Saturday, 9 October. Future dates for Interim Meeting in 2004 are October 28 and December 2. In 2005: January 27, February 24,

April 28, May 26, and June 23. Friends settled into closing worship and adjourned at 9:15 p.m.
