### **Third Haven Friends Meeting Minutes of the 12th month 11th, 2005, Meeting for Business**

The meeting opened with a period of silent worship. Marsie Hawkinson, Clerk of the Meeting, clerked the meeting for business.

12th Query – During the meeting for worship, Bob Marshall read the 12th Query on Simplicity and Integrity. There were no further comments on the Query in the meeting for business.

Minutes of the 11th Month 13th meeting for business – The Meeting APPROVED the minutes of the 11th month 13th meeting for business, as distributed electronically to Friends with e-mail addresses and mailed to others.

Clerk's correspondence and announcements – Clerk Marsie Hawkinson reminded Friends that Third Haven will have regular meetings for worship at 10:00 am on 1st day 12th month 25th and 1st month 1st, though there will be no First Day School on either date. The Meeting will have a special meeting for worship on 12th month 24th at 3:30 pm. The son of Edith and Herbert Taylor donated 2 of Joyce Zeigler's paintings of Third Haven to the Meeting. Marsie sent a note of thanks and noted the contributions of these 2 Friends to Third Haven. The paintings now hang in the common room.

As approved in the last meeting for business, the Clerk sent a letter to the Interfaith Housing Development Corporation. Larny Claggett reported that the Interfaith Housing Development Corporation has asked Third Haven to secure \$25,000 of a loan, with other amounts to be secured by other area churches. This request was referred to the Budget and Finance Committee, which will make a recommendation to the Meeting at the next meeting for business.

Treasurer's report – The Treasurer, Joe Davis, presented the financial reports for Third Haven for 10th and 11th months. The income for 10th month was \$3,820; the expenses \$6,165, for a negative net for 10th month of \$2345. 10th month expenses included adjusting the boiler, replacement of the oil tank and a final payment for painting the brick meetinghouse. The income for 11th month was \$8,232; the expenses \$1,673, for a positive net for 11th month of \$6,559. The total income for the 7th-11th month period was \$20,789; the total expense for the same period was \$21,816 through 5 months; with a negative net of \$1,027 in the fiscal year to date. On the year to date balance sheet, the total current assets are \$59,204 with total current liabilities of \$10,178. The Meeting has \$49,026 net funds available. The Meeting APPROVED the Treasurer's report with thanks to Joe Davis.

Budget and Finance – Sumner Parker and Norval Thompson have reviewed financial records of the Meeting, in the manner of a "Friendly audit", and found nothing amiss. All is in good order. The Treasurer, Joe Davis, is doing an excellent job managing the finances of the Meeting. The Meeting thanked Sumner, Norval and Joe.

As requested at the 11th month meeting for business, Winslow Womack reported that the Budget and Finance recommended that the Meeting lower its financial contribution to Philadelphia Yearly Meeting in fiscal year 2007 (FY07) by \$1,000 to \$13,190 for the "covenant" to be reported to Philadelphia Yearly Meeting in 1st month 2006. There then followed another long discussion of the of the financial condition of the Meeting, various interpretations of "budget shortfalls", the fact that many members and attenders do not financially support the Meeting, what might be done about these matters and which committees have related responsibilities. The Meeting finally AGREED that Third Haven will pledge to pay no less than \$13,190 to Philadelphia Yearly Meeting for the FY07 "covenant" to be reported to Philadelphia Yearly Meeting in 1st month 2006.

Worship and Ministry Committee – Bob Marshall, Clerk of the Worship and Ministry Committee, presented the 2005 Annual Report for the Committee. The Report stated in part, that the Committee focused on 3 activities in 2005: 1) well-attended and thoughtful adult discussions on the peace testimony, simplicity, spiritual journeys, "loving your enemies" and poverty as violence; 2) support for the Library and Outreach Committee, in cooperation with the

Testimonies and Concerns Committee, with educational materials for the Meeting open house on 10th month 1st; and 3) discerning responses to the 2nd Query on the meeting for business. The responses to the 2nd Query were offered as an addendum to the Annual Report, which stated in part – The meeting for worship is at the core of our Religious Society, but the meeting for business should be no less of a worshipful activity. It went on to quote Howard Brinton – “the transaction of church business is as distinctly a religious exercise as is the meeting for worship ... the meeting for worship concerns being while the meeting for business concerns doing.” While the meeting for business is supposed to be spirit-led it can lead to feelings of irritation and frustration. The addendum went on to cite the wise advice from the Elders of Balby, Yorkshire, 1656:

“Dear Friends, keep all of your meetings in the authority, wisdom, and power of Truth and the unity of the blessed Spirit. Let your conduct and conversation be such as become the Gospel of Christ. Exercise yourselves to have a conscience void of offense toward God and toward all people. Be steadfast and faithful in your allegiance and service to your Lord, and the God of peace be with you.”

The meeting for business can be a major source of great spiritual fulfillment for the Meeting community. We should recognize the riches of Third Haven Friends Meeting, and the corresponding stewardship responsibilities. The addendum went on to call for “steadfast adherence to certain core principles in the meeting for business” set forth in the Faith and Practice of Philadelphia Yearly Meeting (2002). The Worship and Ministry Committee recommended that the report be sent to the Meeting community.

The Report and responses to the 2nd Query prompted a period of silent reflection on our participation in the meeting for business. With Friends uniting with this report from the Worship and Ministry Committee, the Meeting APPROVED the Annual Report and the addendum on the meeting for business, with thanks to Bob Marshall and the Worship and Ministry Committee. The Annual Report and addendum on the meeting for business will be published in the Newsletter. The Committee will continue to work on the response the 2nd Query and prepare advice for the Meeting on the meeting for business.

Nominations – Mary Cotton, the Clerk of the 2005 Nominating Committee had previously distributed a preliminary Nominating Committee report and asked Friends to make additional suggestions. In Mary’s absence, Meredith Watters presented the Nominating Committee’s proposed officers, clerks and committee members for 2006 to the Meeting for approval. The report gave “particular thanks to our clerk, Marsie Hawkinson for the care, love and tenderness she has given us all during these past four years.” Meredith noted that the Nominating Committee had made a special effort to reach out to the entire Meeting community, particularly newer members and attenders. Friends made a few additional suggestions. With a few additions and corrections, the Meeting APPROVED the Nominating Committee report, with gratitude to Mary Cotton and the Nominating Committee for a job very well done. The full corrected 2006 nominations will be published in the next Newsletter. The 2006 Nominating Committee will be Meredith Watters (Clerk), Joyce Zeigler and Marsie Hawkinson. The Meeting reiterated its great appreciation thanks to Marsie Hawkinson for her patient leadership, in the manner of Friends, of Third Haven for the past 4 years.

Testimonies and Concerns – Lorraine B Claggett, Clerk of the Testimonies and Concerns Committee, spoke of creating a culture of peace in the Meeting community. The Committee will sponsor a speaker from the American Friends Service Committee (AFSC) on border issues and a simple meal on 1st month 28th, 2006. Friends are reminded to pray with Langley Hill Friends

Meeting for the hostages in Iraq. It was noted the proceeds from the carriage shed sale will be given in 3 equal shares (about \$1300 each) to the Apostles Build program, Caroline County Habitat for Humanity and a Meeting family in need.


Trustees – Pinney Claggett, a Third Haven Trustee, explained in some detail the origin of the Trustees, created around World War II, when it was thought that the Meeting might be laid down. The Trustees is a self-perpetuating body, which consists only of members of Third Haven Friends Meeting at this time. The Trustees hold title to the Third Haven property and have responsibility for the maintenance of the Third Haven buildings and grounds. The Trustees meet officially only once a year. The current assets of the Trustees are estimated to be in the range of \$400,000. These funds are mostly invested with Friends Fiduciary Corporation. There followed some discussion of the roles, responsibilities and relationships between the Trustees and the Meeting, especially the Buildings and Grounds Committee of the Meeting. In particular, Friends asked how the Buildings and Grounds Committee can determine what the Trustees will pay for and what the Meeting, through the Buildings and Grounds Committee, is expected to pay for. As the discussion was lengthening, a Friend suggested that there be a special meeting to discuss the roles, responsibilities and relationships between the Trustees and the Meeting. The Clerk will arrange for such a meeting.

Other Business – The First Day School will present a children’s program at the rise of meeting for worship on 12th months 18th, a pot luck lunch will follow. Norval Thompson thanked the Meeting for trying new things in communications, like the electronic distribution of the Newsletter. The meeting for business concluded with additional appreciation of Marsie Hawkinson for her excellent service as Clerk of the Meeting for 4 years. Marsie in turn thanked the Meeting for supporting her.

The meeting for business closed with a period of silent worship. The next Third Haven meeting for business will be at the rise of meeting for worship 1st month 8th.
