**Third Haven Friends Meeting  
Meeting for Business  
1st Month, 14th, 2007**

Meeting for Business, clerked by Anne Rouse, opened at 11:37 AM with a period of silent worship. The 1st Query had been read aloud in Meeting for Worship. There were no additional offerings. The clerk asked for any additions or corrections to the previous month's minutes. None being offered, the minutes were APPROVED.

The Treasurer's Report was delivered by Joe Davis. Joe stated that at this point, halfway through the fiscal year, our income, at \$35,351.66, is approximately 65% of our budget, while expenses, at \$27,511.76, are around 50%. Comparisons were given to the previous year for the period July through December. Income and expenses were similar in both years, except Attender Contributions were significantly lower in the current year. Total assets, or available funds, are \$65,257.43.

The clerk presented several mail items. The first item was a request from members of Baltimore Yearly Meeting who are writing a book about conscientious objectors, particularly those from the World War II era. They have found an individual in Easton they would like to have interviewed (Gilbert Walbridge) and are requesting a volunteer from Third Haven who would be willing to conduct the interview. Anyone interested can speak to the Clerk.

Another mail item was a communication from FCNL in response to President Bush's most recent speech, detailing its dismay at the president's call for additional troops to be sent to Iraq rather than working on diplomatic solutions. FCNL requests that Friends let their government representatives know of their concern and their disagreement with the president's policy.

There was also an item from Testimonies and Concerns about peace efforts, and a request for Friends to read the latest communication, to be posted.

Winslow Womack reported for the Common Room Committee. In response to a request by an attender for permission to meet in the Common Room with her women's spirituality group, the Committee drew up conditions to be met by said group, which largely parallel regulations for the Common Room listed in the Handbook. Meetings by the group were approved under the conditions as follows: that meetings would be conducted on Mondays through March from 6-8PM, at which time the arrangement would be re-evaluated. Furthermore, women of like interest in the community would be welcomed, the group would bring its own supplies, food and otherwise; and that no admission would be charged. Parking would be restricted to designated lots on the property, no candles or flame sources would be allowed in the buildings, and no alcohol would be allowed to be used anywhere on the property. The committee would like Third Haven to know of the availability of this group to Friends who have a need for such a group. The starting time for these meetings will be listed in the announcements.

A Friend asked if there was an item in their budget to supply a DVD player for Testimonies and Concerns' movie nights, which are to be held monthly in the Common Room. Winslow responded no, to which Ralph Young replied that he would obtain the player another way.

Meredith Watters, Nominating Committee Clerk then reported the nomination of Molly Burgoyne to the position of Recording Clerk, which Molly has accepted. She is currently attending a workshop at Pendle Hill specifically for recording clerks. Meredith queried as to how the Meeting could help Molly pay for this workshop. Molly can, if she chooses, request reimbursement from the contingency fund, or she can write off the expense. A Friend pointed out that there is a line item for conference expenses. It was determined that Molly could, upon choosing to, apply through the clerk, to the treasurer, for reimbursement for her conference fees.

Meredith went on to say that the position of clerk of Testimonies and Concerns is still pending. The Clerk nominated Paige Bethke, and she has accepted, the third position on the Nominating Committee. Also, Meredith reiterated the remaining need for a new treasurer, as Joe Davis would like to relinquish his post, although it is wished by many that he remain, and Friends are deeply grateful for his service to date.

The Overseers' Annual Report was given by Doreen Getsinger. (See attached). At the close of the report, a Friend asked whether Overseers has determined the date of the 2007 Members and Attenders Luncheon. The date has been set for March 25th.

Susan Claggett spoke about the Upcoming Southern Quarterly Meeting, to be held at Third Haven next First Day. She encouraged Friends to arrive early to register and to sign up for the Shreshops planned throughout the day. She also reminded Friends to bring items for potluck, and to please exclude seafood, as seafood allergies are a concern. The schedule for the day will be posted in the Announcements, and child care will be available. It was determined that breakfast will be provided by Hospitality. Susan requested help with registration duties, and that Friends wear name tags, stating that she expected up to 70 attendees.

Marsie Hawkinson reported for Interim Meeting. She, Doreen Getsinger, Norval Thompson, and Cathy Thompson have been to PYM to meet the three remaining candidates for General Secretary. Marsie remarked how the experience had been uplifting and encouraging; that all three candidates were supremely qualified and wonderful, each different, each recommendable. The resumes for each candidate are posted in the Common Room. In response to a Friend asking whether all three were from PYM, Marsie replied yes, although announcements for the position had gone out beyond PYM. Another Friend gave thanks for those who attend Interim Meeting regularly and keep the meeting apprised of happenings there. It was asked how much of the budgeted \$150,000 was spent on the candidate search and process. Norval responded that it is on the agenda to discuss at the next Interim Meeting. Another Friend involved with non-profits indicated that this sum is in line with what non-profits spend on such searches. She offered her assistance in addressing these issues.

Frank Zeigler spoke in behalf of the Library and Outreach Committee. In response to the committee's request for ideas about creating more shelf space for our library, Frank has received only one reply. He reiterated the pressing need for space and new additions to the collection, not to mention the deteriorating condition of the books, some of which are extremely old. One idea has been to donate some of the books to other meetings, but Frank says that most other meetings have the same books. The committee needs continuing input from Friends as to how to dispose of the books and on the acquisition of new ones. Frank opined that the status quo is not acceptable. One Friend suggested an ad in the Friends Journal listing available books. Another two friends discussed giving authority to the committee to dispose of the books as they see fit, with the possibility of giving away books to interested members. Building shelves in the Common Room was presented as an option. It was decided with APPROVAL that the Committee would come back to the Meeting with options and suggestions, with one friend withholding approval. The Annual Report of the Committee will be presented next month.

With no additional concerns or business forthcoming, the meeting was closed with a period of silent worship and concluded at 12:15PM.

## **General Secretary Selected**

Report to Interim Meeting of Philadelphia Yearly Meeting by the Search Committee for the General Secretary January 25, 2007

We bring to you with unity and joy the name of Arthur Larrabee for the role of General Secretary.

We note his years of service to his MM and to PYM in a multitude of roles, including Clerk of Yearly Meeting and current Clerk of Interim Meeting

We recognize his highly regarded qualities as consultant and teacher on Quaker decision-making and clerking by Friends all over the country

We are impressed by his skills as a mediator in school settings

We are aware of his history as an attorney in his own law firm and his administrative experience there

We experienced his clear grasp on the challenges and—in his way of thinking—the opportunities before PYM

We found that he has clarity on the nature of the General Secretary role as defined in the job description and the nature of the transition he will need to undertake as he moves from Clerk to this lead staff role.

Finally, we all know of his deeply spiritual center and his unique ability to articulate and act out of that center.

We strongly urge that consideration of and action on the proposals of the Transition Project Group continue move forward expeditiously. They have been a part of our discussions with each of the candidates. We believe that action on these recommendations will create a supportive and promising context in which the new General Secretary will be able to work.

In keeping with the spirit of those recommendations and in light of the job description, we hope that Interim Meeting will encourage and welcome the General Secretary's initiative in a creative review of the structure of Yearly Meeting staff. He needs to assure that it is well aligned with the directions put forth by Yearly Meeting and that utilizes individual staff in ways that are aligned with their skills and passions.

Generational Transition in PYM As the committee has worked over these months, we have found ourselves increasingly united in concern for the challenge of generational change in the yearly meeting and in its leadership. We have come to see this concern is not principally a matter of worrying about where the Friends and leaders of the next decades will come from; many are in our meetings and involved in our programs.

They are participants in our programs for Young Friends and for Young Adult Friends. They are active in Quaker pursuits in our schools. The challenge before us is how to make the structures and processes of our Monthly, Quarterly, and Yearly Meetings conducive, welcoming, and accessible to these next generations of Quaker leaders. There are particular challenges related to deep engagement of our young families as they have to weigh their commitment to Quaker processes with their other pressing obligations. The Search Committee has heard from across PYM concerns for broader inclusion of Young Friends, Adult Young Friends, and Friends with younger families in our processes, structures and life as a yearly meeting. The Search Committee urges that Interim Meeting work with the new general secretary to consider and create paths towards this goal of PYM growing to be a more vibrant intergenerational and multigenerational community.

The Search Committee recommends that the year to year relationship between the Yearly Meeting and General Secretary be undertaken with an expectation of five years of service, at the end of which there would be a fundamental, mutual evaluation of whether it should be extended beyond this timeframe.

The period of five years is intended to provide a time-frame to Arthur as he undertakes his new responsibilities. It would create a known time in the future when both he and the Yearly Meeting can consider freshly his service in the capacity of General Secretary. It would provide a setting in which neither partner in this relationship feels or becomes trapped.

This recommendation assumes timely, thoughtful, and honest annual performance evaluations and annual reappointments within this broader expectation of service. If Arthur's service should be extended at the end of five years, it would represent an explicit renewal of the commitment on the part of both partners and an occasion for another fresh beginning.

Again, we have shared this recommendation with Arthur and he supports it.

#### Timing of Appointment

The Search Committee recommends that Arthur's assumption of responsibilities as General Secretary begin on April 1, with he and Mark Myers spending blocks of time together in the next two months as times for orientation and transition.

#### Request by Search Committee to be Laid Down

Members of the Search Committee have offered themselves to be available to Arthur as an informal transition consulting group to be used if and as Arthur feels it would be useful.

But we have completed our formal assignment and ask to be laid down. We make this request with deep appreciation to the Yearly Meeting. In our last session on Sunday afternoon, each member of the committee articulated his and her gratitude to the Yearly Meeting for providing us the opportunity to participate in this process and to experience, through it, our own spiritual growth. We came together as a formal committee, many of us strangers to one another. Lyle Jenks reminded us that we needed name placards in our early meetings. Our group evolved into a trusting, loving, and intimate community.

Moreover, we have felt sustained and supported throughout by your thoughts and prayers. And we have been given fresh hope for Philadelphia Yearly Meeting by the inspiring people who put themselves forward as candidates and by the spirit of the widespread participation in the process. ### **Contemplating Conflict: Rule 3**

Have you ever thoughtfully wondered after the fact why you did or said something? Perhaps this question was even accompanied by a regretful, "What was I thinking?" This is the question we must raise with ourselves as we pursue conflict resolution. In the school peer mediation program, conflict disputants were asked to commit to four rules, including Rule 3 BE AS HONEST AS YOU CAN. Now honesty is certainly a foundation of Quaker tradition; here we are talking about internal honesty. As we discuss matters in Meeting for Worship for the Conduct of Business, are we honest with ourselves about our motives and biases? Then are we honest and straightforward with others not only about our views but also about the basis for those views? Being open about "What was I thinking?" leaves us vulnerable and requires some degree of trust that we will be treated gently by Friends. With Rule 1: Do Not Interrupt, and Rule 2: No name calling or put downs, Rule 3: Be as honest as you can, contributes to an environment where thoughtful people can resolve conflicts peacefully. *submitted by Dee Rein*
