# Third Haven Friends Meeting Meeting for Business Minutes for the 2nd Month, 10th, 2008

The Assistant Clerk of the Meeting, Candace Shattuck, presided over business meeting. She opened the meeting after a brief period of silent worship at 11:40 AM.

Query: The 2nd Query, "Meeting for Business" was read during meeting for worship by Leonard Baynham. The query generated much discussion and thought during the worship service

Approval of Minutes: After a name correction, Jessica "Wright" to "Rice", the minutes were approved from the 1st Month.

Clerk's Correspondence: Information regarding two upcoming programs planned by PYM and Earlham School was given. The first is called, "Vitality among Friends" and the second is "Leadership among Friends". Cost for participants is \$20 for each program. Two letters requesting membership were read. The first letter was by Clay Owens. A clearness committee has been formed to meet with Clay. The second letter was written by Gwen Beegle and will be turned over to Overseers for consideration.

First Day School Report: Two of our young Friends; Emma Leibman and Evan Claggett, gave a wonderful report on their recent trip to Burlington, NJ to participate in a gathering of middle school aged Friends. The meetings for business and worship were run by middle schoolers. They also took part in hospitality and cleanup. The worship sharing sessions were particularly good. We are grateful these Friends had the opportunity to go to this gathering and come back and share with us.

Recorder's Report: Please see full attached report. In 2006 there were 129 members. In 2007 there was 1 infant, 1 death and 4 new members for a total of 133 members.

Overseers Report: Clerk of Overseers commented on three items. First of all, the memorial service for Jake Kemp was well attended and the old meeting house was used for this. Secondly, the welcoming committee has met with John Todd and consisted of Lorraine Claggett, Irene Williams, Meredith Watters and Leonard Baynham. Our Meeting again welcomes John to our community. Thirdly, Overseers plans to expedite membership requests. A clearness committee for Clay Owens has been formed and will consist of Candace Shattuck, Nancy Mullen, Larny Claggett and Marsie Hawkinson. A clearness committee for Gwen Beegle will be formed before the next business meeting so that her membership request can be processed and moved forward. Request for Funding: Ralph Young requested approximately \$150 for supplies for Marilla's lunches and \$75 for the Prison Action Fund Library. These monies had been shifted over to the Carriage Shed Sale line on last month budget. The Treasurer reported that it would be no problem to shift these monies back to help these programs if the Meeting approved. The Meeting approved the transference of these funds.

Library and Outreach: This committee's annual report is attached in full. The committee has undergone a yearlong effort to review the entire collection. In 2008, they hope to help define and broaden the "purpose" of their committee work and look forward to engaging the entire Meeting with this. The Meeting approved the report with thanks to the committee for their work this year.

Communications: This committee's annual report is attached in full. The Meeting is encouraged to use the website www.thirdhaven.org with its new updated features. The Meeting approved the complete report with many thanks for the hard work of this committee.

Interim Meeting Report: The full report is attached.

Other Concerns: The Treasurer brought two items to the Meetings' attention. The first item is the need to let PYM know if THFM will be giving PYM the same amount of money this year as last. Last year's covenant was \$15,000. Since both budgets come out at the same time, it makes it more difficult to promise the same amount before our Meeting has its budget discussions. After some views were aired, the Meeting discerned it reasonable to project that at least \$15,000 will be our contribution again this year and that this amount will be finalized when the yearly budget is approved. This will be turned back over to Budget and Finance. The second item involved a survey distributed by PYM regarding our Meeting use of resources (time, money and space) that needs to be filled out. It was decided that the survey will be published in the announcements and responses to it can be forwarded to Rob Wieland. He will then share this with Budget and Finance and then the final survey will be brought back to business meeting next month.

After a brief period of silent worship, the meeting for business was adjourned at 12:35. *Respectfully submitted, Molly Burgoyne*

SQM wished to thank Dana Hester-McCabe for all five years of wonderful work. Dana was felt to be spirit-led, experienced and helpful to struggling meetings who called on her assistance.

One Friend felt we had left untouched the issue of our commitment to Southern Quarterly Meeting and requested that all consider this and return to it in the future. All felt it was critical that the May program be a good one that will draw members out. It was asked that each Monthly Meeting discuss their level of commitment and bring that to the next Planning committee meeting.

All present agreed the SQM should continue meeting three times yearly. The next SQM will be at Wicomico Monthly Meeting the third 1st Day of May, 2008.



Consensus was reached about Southern Quarter agendas: In January we will attend to the business of SQM with an emphasis on the spiritual state of each monthly meeting. In May and October, each meeting will present brief updates on the state of their meeting followed by a planned program or fellowship or both.

There was not unity regarding the position of paid coordinator but those present agreed to lay the matter aside and not hire a new coordinator at this time. This did not mean we cannot revisit the possibility of hiring someone for this position in the future.

There were around 35 middle school age kids (and 8 adults) gathered at Burlington for a weekend workshop on Bullying. Friday night was welcome everyone and get to know you. Each kid was assigned a small group which had duties to do throughout the weekend (like breakfast set- up) We also met in these small groups to discuss Quakerism and bullying. Saturday was filled with activities from speakers to sharing life stories. Food served was excellent and Saturday night the whole gang went ice skating!! A highlight for many of the young Friends. We had small group meetings and closure on our weekend all on Sunday am including a business meeting and meeting for worship. Everyone chipped in to help clean the conference center and we all left by 12 noon. I felt the gathering was so well run because of the organizational skills by the PYM MSF staff person named Elizabeth Walmsley. Hats off to her and her staff. #### The Peace Testimony and the War in Iraq: Toward a Quaker Response

The following statement is the work of the entire PYM Peace & Concerns Standing Committee. Our peace testimony is an important part of our identity as Friends. There are many ways to live out a peace testimony: refuse to participate in war, try to stop war, share tools of dealing with conflict without violence, live lives that don't nourish the seeds of war. Our country is at war.

In our most recent experience with war, the Vietnam War, much of our focus was on trying to stop it. All our efforts, along with the efforts of many others in the anti-war movement, had enough success that we have tried to do the same with the Iraq War. Many of us are very disheartened at our failure.

Looking back further in history, however, some of our proudest moments as Quakers came in relation to wars that we were not able to stop. The massive feeding programs after World War I, and the rebuilding programs after World War II brought Quakers together, gave common work, allowed us to visibly live out our beliefs as a faith community.

Perhaps it is time to focus once again on healing from war. There is certainly healing to be done. US Iraq war veterans are coming home in deep physical and mental pain, with heart-wrenching family break-ups, job instability and homelessness on the rise. There are now over 4 million Iraqi refugees, both displaced internally and living outside Iraq -- an enormous humanitarian catastrophe. The land of Iraq has been assaulted.

A focus on healing would ground us in love. It would center our faith communities in spiritual rather than political work. Rolling up our sleeves and doing the work that is there to be done -- with US war vets and Iraqi refugees -- would get us out in the world together, living our Quaker faith. We would learn a lot. Perhaps we would do some good.

God does not call us to be successful but rather to be faithful. What if some Quaker organizations cooperated to set up opportunities to be involved in healing work? What if every Monthly Meeting directly addressed the reality that our country is at war and decided to play a role in healing, knowing that they were part of a common effort, that this is what Quakers do?

#### 2007 Annual Report Library and Outreach Committee

Third Haven Friends Meeting 10th Day Second Month 2008

The Library and Outreach Committee had an active year. In February, the Clerk attended an all-day special workshop held in Philadelphia by PYM for Clerks of Library committees of Monthly Meetings. This well-attended workshop included Clerks from as far away as Colorado, North Carolina and Maine, and included formal presentation by outside experts as well as opportunities to share common challenges and solutions. The focus of the workshop was on issues including discussions on the purpose of libraries within the Monthly Meeting, anticipating the impact of Web 2.0, the maintenance of collections including accession and de-accession issues; practical to solutions to common problems faced by Committees and options for cataloguing and tracking. Sharing issues and solutions between Clerks was enormously helpful, and helped shaped discussions within 3HFM's Library and Outreach Committee during 2007.

Energized by the workshop, the L&O Committee embarked on a year-long effort to review the entire collection, review the use of overstuffed shelf and cupboard space, assess the special needs of the 'older book' collection and consider options for culling, relocation and re-distribution. As a result, several actions were undertaken.

A new home for the 'older book' collection has been created by the construction of a bookshelf built in the Common Room, above the coat rack, and the collection has been moved to this space. While this is not an ideal location, it frees up space allowing for the re-distribution of the circulating collection, to enhance accessibility to all members and attenders. The L&O Committee does check periodically with local and historical library collections to determine if they are willing/interested in any of the books in our collection. Unfortunately, there are not many 'homes' for these volumes. This is an issue other Monthly Meetings share as well. In conjunction with the Carriage Shed Sale, Library and Outreach reviewed our entire circulating collection, and determined that only a limited number of books would be kept in duplicate. Duplicate books or older, un-circulating or duplicate pamphlets were offered for sale at modest cost during the Carriage Shed sale. This served several interests including expanding the reach of Quaker related writings within our own community; allowed us to 'clean house' in the circulating collection space; and gave us additional space for our ever-expanding collection. We had an excellent 'sale', successfully 'de-accessing' a number of books and pamphlets into the hands of interested parties.

Another idea brought back from the conference was to begin a thoughtful discussion about the 'purpose' or mission of our library specifically, and to engage the wider 3HFM community in this discussion. This is anticipated to start in 2008, and will be a multi-year process. We will be sharing specific plans for this activity this spring. Included in this discussion is how we might use and share new technology to make Quaker writings more accessible to our community including the possible use of a new collection cataloguing system that builds upon the new Web 2.0 For those for whom this sounds formidable, please be assured we will keep the full range of options open, and will continue to have books, pamphlets and other materials available. We welcome any members and attenders to join the committee in developing the plans for this discussion.

In November 2007, L&O once again hosted an open house during Waterfowl Festival. We had an excellent turnout of volunteers to guide and answer questions, but had fewer than 10 visitors. We've discussed ideas for expanded publicity next year, as well as other options that would

make our location easier to reach. We still view this as a major opportunity to share our lovely

grounds and history to visitors.



We continue to replenish our supply of brochures and pamphlets as needed, including our introductory materials and continue to recoup some costs through sales. Our committee continues to correspond to visitors who sign our guest book. We look forward to the coming year as a year of assessment and planning to more fully meet the needs of our 3HFM community.
