Carriage Shed Sale

The Third Haven Friends Meeting will host the Carriage Shed Sale on September 27th from 8 AM to 1 PM, Rain or Shine, on the Meeting House grounds. The Carriage Shed Sale offers a wide assortment of treasures and collectibles, from attics and basements, including: furniture, house wares, linens, glass wares, books, games and toys, sports equipment, crafts, tools, garden items, baked goods, and other assorted categories. Two big attractions will be the "Quaker Dogs" and a Silent Auction. There is something for everyone. Mark Beck and Paige Bethke are co-chairs of the sale this year.

The proceeds from the Carriage Shed Sale will be equally distributed among three projects in keeping with Quaker testimonies of education, equality and non violence. The projects identified for support include: Third Haven Friends Scholarship Fund, a newly created program to promote Quaker education opportunities; Fresh Start – a local initiative to create a transitional housing program for those who have successfully completed a rehabilitation program and are recovering from substance abuse; and "Buy a Locator – Save a Life" a program to purchase Schonstedt Locators, at a cost of \$750 each, that are used by war torn countries to find steel and iron objects that are buried 10 feet deep and are the perfect tool for discovering unexploded ordinances. The program provides for the Schonstedt Locators to be sent directly to people in countries that have bombs to be disarmed like Bosnia, Herzegovina, Laos, Somalia and Tajikistan. Friends are hoping to raise enough money to purchase 4 Schonstedt Locators. The common room will be saved for the sale the two weeks before the sale. The calendar in the common room is blocked off during that time. This way we will have more space to put things and more time to organize. Friends have offered other storage space so that we might begin collecting items earlier than we have in the past. This might be very helpful if someone is moving between now and September and needs to get rid of things sooner than later. If anyone has a need to have items stored earlier than the Sept. sale date, please contact either Paige or Mark.

Third Haven Friends Meeting Minutes of the 6th Month 8th, 2008, Meeting for Business

Following a period of silent worship, John Schreiner, Clerk of Meeting, conducted the meeting for business.

Query for 6th Month – The 3rd query on Equality was read during meeting for worship. Several offerings of vocal ministry spoke to the query. The Clerk asked for additional reflections. A Friend stated that she did not like the distinctions that differentiate and separate us. She said she wanted a peaceful Meeting. Another Friend noted that we are not the same and so inherently unequal; equal treatment is what matters. Another Friend added that the queries help draw attention to our consciences.

5th Month Minutes – The Clerk noted that the 5th month minutes did not note that the Worship and Ministry Committee presented "Advice on Vocal Ministry and Afterthoughts", written and read by Bob Marshall, which was discussed and APPROVED by the Meeting. The Meeting thanked the Worship and Ministry Committee for this contribution. With this addition the 5th month minutes were APPROVED.

Clerk's Report – The Clerk noted for the record that the Meeting had held a memorial meeting for worship for Robert Matthew (Matt) Wieland in the old meetinghouse on 5th month 26th. The Meeting commuty continues to hold the family in the Light.

The Clerk read a letter, dated 6th month 2nd, from Mike Mullen, canceling his membership in the Meeting. His letter noted his discomfort with "discrimination" against homosexuals and "some disappointment about the religious nature of the community." Acknowledging the resignation, the Clerk suggested Overseers form a committee for understanding and healing. The Meeting's committee for welcoming Gwen Beegle has completed this welcoming. Treasurer's Report – The Treasuer, Robert Wieland, presented and explained the Meeting's financial report for 7th month 1st, 2007 – 6th month 7th, in terms of both assets and liabilities,

and income and expenses. This represents very nearly the full 2007-08 year for the Meeting's finances. The Meeting has \$67,449.67 in total assets. In 2007-08, the Meeting had \$50,431.60 in total income, \$3,438.40 less that the approved budget (\$53,870). In 2007-08, the Meeting had \$47,044.97 in total expenses, \$6,836.03 less that the approved budget (\$53,870). Thus, the net income for the year is \$3,397.63. [See the attached financial reports.] This led to interpretations and a discussion of the shortfall in budgeted member contributions, savings on expenses, various components of the budget and the need for more financial contributions to the Meeting. After some further discussion, the Meeting APPROVED the Treasurer's Report, with thanks to Robert Wieland.

2008-09 Budget – Winslow Womack, Clerk of the Finance Committee, presented and explained the 2008-09 budget for Third Haven. With some modest increases and decreases in various budget categories, the proposed budget is \$57,627 for 2008-09, a increase of \$3,757 or 6.5% over 2007-08. This led to a discussion of the proposed budget and ideas for renewing efforts to secure more financial contributions from our approximately 115 members. After some further discussion, the Meeting APPROVED the proposed budget of \$57,627 for 2008-09, with thanks to Winslow Womack and the Finance Committee.

Minute on Slot Machines – Lorraine B Claggett, for the Testimonies and Concerns Committee presented a minute opposing the introduction of slot machine gambling in Maryland. After some discussion, the Meeting APPROVED the proposed minute. [See the Attached minute.] The Clerk and the Testimonies and Concerns will disseminate the minute to the proper authorities.



First Day School – Cathy Thompson read the Annual First Day School Report, for Susan Claggett, Clerk, and the First Day School Committee. Attendance averaged 13 children, with over 30 visitors, in First Day School this year. Some of the highlights of the year included Godly play, reliable child care for the meeting for business, food and hunger, wreath making, the Christmas play, middle school Friends gathering in Burlington NJ and being thankful. Many contributed to the success of the First Day School this year. After some discussion, the Meeting APPROVED the First Day School Annual Report

with great thanks to Susan Claggett, the First Day School committee and all who nurture the children of Third Haven.

Fresh Start – Paige Bethke, reported for Ralph Young, on Fresh Start, a new program on the midshore to provide transitional housing for individuals recovering from substance abuse. Paige provided a program brochure and asked the Meeting to approve a letter to Fresh Start President, Dale Skinner, on support of this program effort, in which Ralph Young is involved. The Testimonies and Concerns Committee will provide \$250 to help Fresh Start secure 501 (c) 3 tax exempt status. After some discussion, the Meeting approved the proposed letter of Support. The Meeting may determine how to support this effort in additional ways at a later date. Philadelphia Yearly Meeting Interim Meeting: Cathy Thompson reported on Interim Meeting , noting: the General Secretary's report from Arthur Larrabee on the appointment of new staff; the Governance Project Group report, which will be presented for approval at the annual sessions this summer; the Budget Process Group report, which will lead to the conversion of \$17.73 million in "designated funds" into the General Fund; the Arch Street Meetinghouse Group report, which proposes to establish a single oversight committee to function as a board of trustees for the Arch Street Meetinghouse project; and the annual fund report, which is about \$100,00 below the year's goal. There was some discussion of this report. The Meeting noted its gratitude to Cathy and Norval Thompson, Doreen Getsinger and Marsie Hawkinson for their faithful participation in Interim Meeting on behalf of Third Haven. In this connection, the Meeting APPROVED a minute in support of the proposed Peace Tax Fund Act (HR1921). [See the attached Peace Tax Fund Report.]

Other Business – The Clerk announced that, as discussed at the all-clerks meeting the previous day, the Meeting intends to proceed with a carriage shed sale on 9th month 27th. Sarah Sayre, on behalf of the Testimonies and Concerns Committee, proposed that the Meeting make the following financial contributions for 2007-08: \$500 to American Friends Service Committee (AFSC), \$500 to Friends Committee on National Legislation (FCNL), \$250 to P.E.A.C.E, and \$250 to Fresh Start. After a very brief discussion, the Meeting APPROVED these financial contributions. This \$1500 is not yet reflected in the financial report (above). There being no further business, the meeting for business concluded with a period of silent worship.

Minute on Slot Machines – Lorraine B Claggett, for the Testimonies and Concerns Committee presented a minute opposing the introduction of slot machine gambling in Maryland. After some discussion, the Meeting APPROVED the proposed minute. The Clerk and the Testimonies and Concerns will disseminate the minute to the proper authorities.

"Third Haven Monthly Meeting, assembled for business on sixth month, eighth day, is opposed to the introduction of slot machine gambling in Maryland and to making five state slot machine locations mandated in the state Constitution, a document that is intended to outline basic freedoms granted the people and stipulate the form and structure of state government.

We find that gambling is contrary to our testimonies against addictive behavior that can separate us from God, our families and friends. It brings with it the huge social, moral and economic costs of poverty, disrupted families, and violent and financial crime.

Gambling takes productive revenue from the local economy and diverts it to a few politically connected and often out-of-state individuals. The revenue that will be generated is uncertain, but huge sums must be waged to gain the proposed state revenue of 6 to 7 million dollars. There is no evidence that this device will successfully reduce tax dollars; but the slot machine revenue does become an additional tax on those least able to pay it.

Third Haven Meeting supports state revenue collection that is just and fairly apportioned to those most able to pay and a state climate that values its commitment to education, quality jobs for its citizens, our natural environment and the welfare of our people. " June 8, 2008

Report on Interim Meeting of June 26, 2008

General Secretary's Report: Arthur Larrabee introduced the following new staff: 1) Christie Duncan-Tessmer as Associate Secretary for Program and Religious Life, 2) Kathy Reilly as Associate Secretary for Business and Finance, 3) Ventina Hershey as Business Coordinator, and 4) Wright Horne as Associate Secretary for Advancement and Communications. A meeting was recently held at 4th St. and Arch to welcome Iraqi refugee families who have moved to the Philadelphia area and who have been sponsored by several Monthly Meetings. Peace & Concerns Standing Committee participated in this event and Arthur said he attended and was very moved by the stories told by the families. He is proud that "our real estate" serves as a Quaker witness to the world of our outreach and testimonies. Our other real estate is the Friends' Center recently visited by Philadelphia's mayor who lauded the greening project and cited it as an example to our nation. Arthur announced that the Friends' Center loan closed on June 4th. Interim Meetin (IM) Governance Project Group Report: Thomas Swain, YM Clerk, suggested that the report be considered over the next three sessions of YM – July '08, March '09, and July '09. Much discussion ensued. The report may be viewed on PYM's website: www.pym.org. IM 2008-2009 dates: IM has decided to meet on Saturdays for the next year, September to June, and will assess at the end of that year whether or not to continue. The suggested time frame is 9:30am – 1:30pm. This is a change from the current Thursday night time frame of 6-9:30pm in the hopes of attracting people who could otherwise not attend.

IM Naming Committee: Marsie Hawkinson presented a report stating that a group of IM members had approached the committee with a desire to name a new IM Clerk and Alternate Clerk. Two names were proposed: Tom Armstrong as Clerk and Bill Pickering as Alternate Clerk. A very lengthy and emotional discussion ensued while the acting Clerks waited in another room. IM finally approved of asking Jada Jackson, the current Clerk and Tom Armstrong, the current Alternate Clerk to remain in office until September, to which they both agreed. The Naming Committee is tasked to meet again this summer and propose new names for Clerk, Alternate Clerk, and Recording Clerk.

The Naming Committee proposed the name of Charles Jackson to replace Marsie Hawkinson whose term on the committee has ended.

Peace & Concerns Standing Committee: Patricia Finley, Clerk, read a minute from Landsdowne Meeting, Pa. for Paul Sheldon, who is traveling to the 12th International Conference on War Tax Resistance and Peace Tax Campaigns to be held in Manchester, England, September 5-7, 2008. The conference will bring people of conscience from around the globe to meet on issues of peace tax fund legislation and conscientious objection to war taxes. Paul has been a war tax resister since 1988. Last month, IM approved sending a letter concerning the Peace Tax Fund to members of Congress. FCNL has recommended that this wait until after the Presidential election in the fall when the Congress re-convenes and when the bill is presented again. This was approved.

Annual Fund Report: Wright Horne reported that PYM is \$7,000 short of its goal and provided IM members with a humorous skit to encourage payments by the June 30th deadline. Report submitted by Interim Meeting representatives: Marsie Hawkinson, Doreen Getsinger, Cathy Thompson, and Norval Thompson

Betsy Harrell writes, "I will be sending a copy of the newsletter of Friends House in Santa Rosa, CA. My interest in sending Third Haven this little publication is twofold. One is that I'd be so happy if any Third Haven members wanted to visit or move here! Santa Rosa is 1 hour north of San Francisco & is located in what's called the North Bay. Most residents are from the San Francisco Bay area; however, we have recent new residents from both Vermont, Florida & New York City. And we have a magnificent climate (except for bad drought this year). About 40% of the independent-living residents are Friends, & we wish we had more."

The increasing price of food and gas has resulted in fewer donations to the Maryland Food Bank. The primary food pantry in Easton for those in need is in the Neighborhood Service Center and the need is increasing. The Maryland Food Bank is the principle source of food for the Neighborhood Service Center. Thus the situation at present is less food for more people. To help fill this gap, several faith communities in Easton are regularly collecting non-perishables to give to the Neighborhood Service Center. On a bench along the East side of the Common Room is a plastic container marked "Third Haven Food Bank for the Neighborhood Service Center". It is hoped that all members and attenders will bring at least one non-perishable each time they attend a Meeting for Worship" Each Monday, the contents of the container will be brought to the Neighborhood Service Center.

The following is a note received from Mariann Stackpole who works directly with the migrant workers. "Thank you on behalf of our migrant workers for being so generous in answering their needs." Once again the requests for workboots continues. Each week more men arrive ill equipped for the work they must do.

Kelly Uphoff writes from Georgia, "Hello, my name is Kelly Uphoff. I grew up in Easton, attended Quaker meeting during my childhood, and worked closely with the late Marilla McCarthy. I am now a Peace Corps Volunteer in the Republic of Georgia. You have probably seen on the news what has happened in Georgia as a result of Russian military action. My site, Gori, was hit especially hard. I am currently in Armenia, waiting for our close-out process. However, I am returning to Georgia to start a new NonGovernmental Organization (NGO) that would assist IDPs and also provide essential materials to Gori University, the only institution of higher-learning in my region. University buildings were destroyed during Russian airstrikes and afterwards, books, computers, everything was looted by Russian and Ossetian forces. Most staff and students are currently IDPs, unable to return to Gori, let alone to school or work. For this reason, our NGO will be developed as an "IDP Education Fund" providing assistance directly to IDPs and to the University.

I am currently searching for an American partner organization to serve as our NGO's "fiscal sponsor". A fiscal sponsor would be any organization with 501 C 3 status that could serve as a connection between our donors in the United States and our NGO here in Georgia. In this relationship, our NGO would serve as one of the sponsor's "projects" and donors would benefit from this tax exempt status. I am interested in contacting organizations that are affiliated with the Quaker Church and that may be interested in forming this partnership. Perhaps you or other members of Third Haven meeting have contacts I could pursue?

I appreciate any help or suggestions you can provide. Beyond these initial contacts, I hope to collaborate with Third Haven meeting in the near future, once I am able to return to Tbilisi and the NGO is fully established. Much of my motivation and sense of social justice came from my experience with the Quaker community, Marilla in particular. Perhaps we can work together to fundraise for this effort. THIRD HAVEN SCHOLARSHIP FUND

Dear Friend,

It's hard to open a newspaper without reading the phrase, "Our children are our future." It is spoken or written by boosters of everything from Head Start to computers for high schoolers. Indeed, it is already a cliché.

WHY DO WE NEED A SCHOLARSHIP FUND?

However, like almost all clichés, it is true. Today's First Day School students are Third Haven's future. The 5th Query asks us, "What help do we provide for the children and adults in our Meeting to pursue the education they seek...?" With your help, we can answer that query. We are in the process of launching a Scholarship Fund to help members of this Meeting and their families pay for secondary and postsecondary education.

The 5th Query also asks, "What is our Meeting's role in the life and support of Friends' education?" and "Do we make provision for children in our Meeting to attend a Friends school?" The Scholarship Committee will also consider those questions as it reviews each application. Ideally, our scholarship recipients will attend schools that instill, promote, embody and reflect Quaker values, and will go on to lead lives shaped by those values. That does not mean Quaker schools exclusively, although the Committee is likely to look favorably on Quaker schools.

ELIGIBILITY

A Scholarship Committee will consider applications from high school students, high school graduates and college, graduate and vocational students of any age. The Committee will consider several criteria, including:

• Student's academic record, community activities, financial need, educational goals and participation in Meeting

• The impact of financial aid: How much of a difference will our scholarship make to reaching his or her goals?

• The likelihood that the applicant will complete his or her education successfully

• The applicant's family's participation in Third Haven, and commitment to his or her educational goals

• Letters of recommendation

GOALS

The more money we raise, the more we can award to deserving students. Our initial goals are twofold: to raise \$60,000 in gifts and pledges to launch an endowment whose income will fund scholarships in the future; and to raise \$6,500 to fund scholarships immediately, beginning this fall. The Trustees have pledged \$1,500, and a \$2,000 line item in the FY 2009 budget was approved at the June meeting for business. That's a great start! In addition to educating our youth, we are building and strengthening our community.

YOUR SUPPORT


