### **Pastoral Care-Annual Report - Bill Schauer ACCEPTED**

The Pastoral Care Committee consisting of Lorraine Claggett, Marsie Hawkinson, Amy Kimball, Terry-Thomas Primer, Katherine Johnson, Susan Claggett, Beth Mufson, Beverley Martin, and Ben Tilghman, clerk of the meeting, continued to meet monthly for the purpose of sharing news of members and attenders, with a focus on those in need of Spiritual support in the manner of Friends and identifying new attenders who might be considering becoming members.

In the spring, we organized the friendly 8's gatherings where members and attenders met for a meal in their respective homes 3-4 times, about once per month. Feedback suggested that this was a great success and will be repeated again in the Spring of 2026.

### **Spiritual State of the Meeting -*Clinton Pettus* APPROVED**

#### **Second Reading and Approval**

The spiritual state of the meeting report was (a) prepared by the Worship and Ministry Committee of the Third Haven Meeting of Friends, (b) circulated via announcements, (c) presented for a first and second reading at meetings for worship with attention to business, 12/28/25 and 1/11/2026 (d) approved for submission to the Philadelphia Yearly Meeting by the Meeting after worshipful discernment. The purpose of this report is to respond to the question “How does spirit move among us?” Using this query, we have engaged in a spirit-led assessment of our worship, community care, spiritual growth, outreach, and challenges.

#### **Red Cards/ICE- *Jim Altman***

Even before the shooting of Renee Good this past week, the Testimonies and Concerns Committee has been working to take effective, peaceful action in response to ICE enforcement actions and the fear ICE has engendered among immigrant and other populations. One small step is to help persons understand their rights if and when they are confronted by ICE. To that end, we have assembled a stack of “Red Cards,” prepared by the Immigration Legal Resource Center, that people can carry and use in the event they are confronted by ICE. Essentially, these “Red Cards” inform people, in English and Spanish, that they have the constitutional right to refuse to speak to ICE officers and that they have the constitutional right to prevent ICE from searching their premises or their belongings, unless ICE presents an effective authorizing judicial warrant.

I have 50 of these “Red Cards” with me. Let me know if you would like one or if you would like some cards to give to others. We can get more cards, if needed.

In the near future, a proposed protocol will be presented to the Meeting for how Third Haven should respond to any ICE enforcement action on Third Haven premises.

Although Third Haven is currently protected by the preliminary injunction obtained by the Philadelphia Yearly Meeting against ICE enforcement actions, that injunction does not prevent ICE from enforcement actions on Third Haven property in all circumstances. Among other things, the proposed protocol will address the important question of whether and when the Old Meeting House, the Brick Meeting House, the Common Space, or any parts of them could be considered private space such that ICE can be prevented from entering them, unless it presents an effective judicial warrant authorizing such entry.

Comments: A process to determine private vs public spaces at Third Haven has been reviewed by an immigration attorney in Easton based on a survey, meeting with the clerk and others, and documentation of the property's ownership. Philadelphia Yearly Meeting has also provided information. Jim prepared some documents which will go to Testimonies and Concerns committee who will work on the issue in order to provide status of various parts of the grounds and buildings. As Quakers all are welcome, this makes it public access, allowing law enforcement access. This topic will be discussed at a later business meeting.

**Peace Vigil/Testimonies and Concerns-Paige Tilghman APPROVED**

**Update on the PEACE vigil** (in front of the county courthouse every Thursday evening 5pm to 5:30pm):

Following research on the history of the Peace Vigil and town insurance requirements, Testimonies and Concerns requests Meeting approval of continuing sponsorship and widening the focus and title of the vigil to: Witness for Peace and Justice. The clerk of our Finance committee is confident that our indemnity insurance would cover this event in case we are required to show proof of insurance.

Once we have the town permit and insurance approved, we will invite members of other congregations to join the vigil. Third Haven Friends are encouraged to put this on their calendars and participate in this weekly witness.

Comments: This is open to other faith groups including Talbot Association Clergy and Laity. People call our phone and ask, indicating interest in participating.

**New Business**

Point of information: Philadelphia Yearly Meeting joint council meeting revealed that they will no longer pay for background checks for people who work with children in Pennsylvania. They will supply the guidelines so we can consider them and see what action we need to take. The clerk will create an ad-hoc group to address this issue. First Day school will work on this.

We have always had background checks for those working with children, often two adults present, which has not occurred recently.

Membership request from John-Leon Donoghue. Pastoral Care will pursue.

Last month Wayne Co. Pa. historical society, sent us a sketch of our Old Meeting House, drawn in 1900 from a photograph. It will be framed for display.

**Richard "Dick" John Smith** passed away peacefully on January 14, 2026, at age 83, at home in Easton, Maryland, surrounded by family. Dick was born November 5, 1942, in Erie County, Pennsylvania, to John Henry and Gladys Otteni Smith. After earning degrees from Gannon and Johns Hopkins universities, he accepted a job at the Department of Defense, where over the next 30+ years he built a successful career and forged lasting friendships.

Dick led an active life. He ran marathons, bicycled across the US, played golf, practiced and taught yoga, and walked to Starbucks for chai every morning he could. His volunteer work included building houses for Habitat for Humanity, volunteering for Partners in Care, serving on the Board of Evergreen Cove Holistic Learning Center, and being a founder of A Community of Transformation. Dick was generous, kind, intelligent, and eager to be of service.

Dick and his wife Katherine enjoyed retired life in Annapolis and Easton, Maryland filled with good friends, spiritual exploration, teaching and practicing Reiki healing, and occasional adventures in ballroom dancing and the arts. They traveled to many places abroad and in the States, including Argentina, Canada, Ireland, Scotland, Mexico, California, Florida, Hawaii, North Carolina, France and other European countries. They enjoyed annual beach visits and Washington state reunions with the Johnson/Jones families. Gatherings with daughters Julia and Rebecca (Pablo), and later the birth of grandson Eliot (now 18 years old) warmed Dick's heart and enriched his world.

Dick is survived by wife Katherine Johnson; daughter Rebecca Smith Hurd (Pablo Ramirez); daughter Julia K. Smith and grandson Eliot Hunter-Watts; step-daughter Ashleigh Creveling (Jimme Pilkerton); brother-in-law Jerry Johnson and family; sister-in-law Ellen Jones (Tom) and their extended family; and Majik the Cat.

## Religious Education Thread Gathering

Philadelphia Yearly Meeting sponsored a religious education workshop at Wicomico River Friends Meeting on January 24th. Melinda Wenner-Bradley from PYM conducted the training, which included many intergenerational activities including a fishbowl/ Faith and Play story and a game called Silent Squares. After lunch, the children had a class with PYM's Claire Kinneel while the adults went deeper into religious ed by watching a video entitled "What do we mean by Worship?" and then heart sharing. Melinda left us with 2 wonderful curricula to allow us to center and go deeper. They are "The Quaker Way Across the Year" and "Walking in the World as a Friend."
