Third Haven Friends Meeting Meeting for Business Minutes for the 12th Month, 2008

I. Call to order:

III. Minutes:

The minutes were approved from the 11th month after the addition of Gabriel duHoffman's last name was added to the list of those attending.

IV. Query:

The 12th Query, "Integrity and Simplicity" was read during meeting for worship. A Friend remarked that this was her favorite query and another remarked that one message of the simplicity query was to help us grant ourselves a quiet place to access a divine center.

V. Quaker Quest:

On January 10th from 10AM to 11:45AM, two leaders from PYM will conduct a session regarding Quaker Quest. We discussed ways to get the word out about this event in order to have many participate. A calling tree will be used. A banner will be placed on Washington St. There will be an article in the newsletter. Some asked if the session could be recorded so that

those who could not attend could watch or listen to it. John Schreiner will call other Meetings in SQM to invite.

- VI. Homeless Shelter: There are now 7 churches signed up to participate in the Homeless Shelter for Talbot County in January and February. Our Meeting will be responsible for the week of Jan. 18th-25th. The overall coordinator is John Hudson. The co-coordinators for our Meeting are Lorraine Claggett and Jamie duHoffman. Lorraine will send a volunteer information form by email to those who have volunteered. An information session for volunteers will be held in the near future and details regarding this will be in the newsletter. Those seeking more information, please contact either Lorraine or Jamie.
- VII. Nominating Committee: Please see attached report. After a few minor corrections, the report was approved by the Meeting. Please note that the clerk for Testimonies and Concerns will be stepping down from this position and that vacancy will need to be filled. The Meeting thanked Meredith, Marsie, Paige and Ralph for their hard work.
- VIII. 325th Year Celebration: Mary Cotton spoke for this endeavor. There has been no formal committee made up for this event but she will hold a meeting regarding plans for the future celebration sometime in January. The meeting time will be in the newsletter. She is currently considering a series of events throughout the year versus smaller "chunks" of events. She wants to consider including the Quaker Quest project and include others from SQM. This is an opportunity to look "inward and outward". Please send an email to Mary if you are interested in participating in these discussions.
- IX. Overseers: Sarah, Laura and Lorraine T. Claggett have participated in a clearing session with Jim Paul, Doreen Getsinger, Cindy Browne, Ralph Young and Candace Shattuck. In unity, the Meeting approved their membership. The welcoming committee will be comprised of Nancy Mullen, Cathy Thompson, Marsie Hawkinson and Paige Bethke with Cathy acting as convener. The Clerk read a letter from Bill Lane, Jr requesting membership. It is interesting that he had been asked to resign from Meeting many years ago because of a "head tax" levied by PYM which evidently had caused several of our members at that time to leave our membership. The PYM no longer has this archaic tax which placed an undue financial burden particularly on children of adult members as they grew into adulthood. Bill and his wife, Barbara, have been attending meeting for worship and Bill has been helpful with Property and Grounds. John Schreiner and Marsie Hawkinson met with Bill and his wife for clearance and pronounced this to be a very happy occasion. They recommended Bill for membership and the Meeting, in unity, approved. A Welcoming committee comprised of Sumner Parker, Joyce and Frank Zeigler and Lorraine will meet with Bill. Sumner will act as convener.
- X. Worship and Ministry: Please refer to attached report. The Meeting approved the report with minor revisions. A Friend asked if this committee would take responsibility for sitting on the facing bench and greeting.
- XI. Testimonies and Concerns: Please refer to the attached minute regarding repeal of the death penalty law in Maryland. This was read aloud and approved by Meeting. If individuals feel called to action, there is information on the Amnesty International website or you could contact John Schreiner or Jim Paul for help and information.
- XII. Treasurer's Report: Please refer to attached sheets. On the balance sheet please note that the Queenstown Bank CD will mature in Feb. 2009. Other issues discussed included the deficit of \$5,209.60 this year in comparison to the last six months of last year. Three thousand dollars of this came from our surplus funds and was given to the Good Samaritan Fund last month. Attender contributions are down from last year. Each February is when PYM requests what the

amount of our contribution for 2009 will be. This doesn't coincide with our budgetary timetable. Traditionally we let them know that the coming year's contribution will be the same as the previous year and if we find we can give more, we will do so later. We will follow the same tradition this year. Many Friends agreed that we need to come to terms with the item listed as Carriage Shed Sale Funds as this probably contains monies to be used for the playground and perhaps other things.

WORSHIP AND MINISTRY COMMITTEE 2008 ANNUAL REPORT

Worship and Ministry Committee is responsible for the spiritual well being of the Meeting community and monitors the strength and depth of the Meetings for Worship. W&M meets monthly with a committee composed of Paige Bethke, Tom Corl, Tatiana Harrison, Bob Marshall, Jim Paul and Meredith Watters. Two recent additions to the committee include Connie Lewis, John Winterbottom, and Denny Bliss.

In January, we were asked by the Clerks Meeting to review the request for After Thoughts and the messages that were offered after the rise of meeting and before "Announcements". W&M was asked to provide a response to guide the Clerk at the rise of meeting for worship. There was a concern that the After Thoughts were not connected to the spiritual tone or content of meeting for worship and, yet, some felt the messages were an important contribution and strengthening to the vocal ministry. We prepared an "Advice Regarding Vocal Ministry and Afterthoughts" distributed at Monthly Business Meeting. This Advice reviewed spiritual discernment and the personal need to express a spiritual leading during the meeting for worship. "Afterthoughts" are an extension of meeting for worship vocal ministry that tend to be founded by: doubt of the root

in the divine opening, insufficient time to formulate the opening, and possibly the inconsistency of the leading with the messages during meeting for worship. The final test recommended by Woolman was to determine if sharing the message or not sharing it would cause personal turmoil. Furthermore, recommended practices by the Clerk to announce "Afterthoughts" and "Joys and Concerns" were also provided. The Clerks Committee considered W & M input and have continued the practice of "After Thoughts" at the rise of Meeting for Worship.

We responded to the quarterly Clerks Meeting asking if the meeting was ready to revisit the issue of same gender union ceremonies at Third Haven Friends Meeting. In January the committee felt that perhaps professional assistance might be required for us to revisit this topic in a loving fashion. A Minute, drafted and submitted by Peggy and Jim Paul, regarding Same Gender Union was approved approximately 5 years ago and remains the guide to this issue, yet, it has been recognized that there remains the existence of continual disquiet with those who would prefer care under the Meeting of same gender unions. We discussed potential accomplishments or perhaps discord created and the timing of readiness for change to the formerly accepted Minute. We let the matter rest.

W & M Committee continues the practice of reading the Queries each month as a continual assignment for members of this committee. The Queries are read during meeting for worship, in preparation for Business Meeting and are appropriate as providing a way to redirect our daily lives in the manner of Friends.

Most recently, W & M has been discerning the properties and merits of a survey instrument used by PYM as a tool to more fully learn about our Quaker community at THFM. The benefits of using a survey of members and attenders designed are being weighed as a method to learn more about their backgrounds, their past religious experiences and their expectations in their participation and practice of Quakerism. This notion is countered by a perceived intrusiveness into the personal leanings of individuals. The survey instrument and the use of it are currently being explored. W & M are discussing the merits of the questionnaire and the benefit to the Meeting community in context with the mission of W & M to provide assistance in the enrichment of the spiritual life of Meeting for Worship.

Another way to support the W & M mission of spiritual enrichment has been to provide encouragement through adult education. Following a very successful Quakerism 101 series last year, presented by visitors from PYM, W & M decided to look at our own members and attenders for examples of Quakerism in practice. Thus, we began a 6 month series of individual presentations, led by W & M members, who describe their spiritual journey to a gathered group following Meeting for Worship on the last First day of the month. We felt this would be an opportunity to further explore the various histories of our members and learn how the practice of Quakerism has influenced their daily habits and lives. The presentations are used to encourage those in attendance to further examine individual and community spiritual lives. W have had two very good programs with Bob Marshall and Jim Paul and look forward to 4 more presentations in the New Year.

Report on Interim Meeting of December 4, 2008 for Third Haven Monthly Meeting.

General Secretary's Report: Arthur Larrabee announced that handouts, as well as minutes for each IM are now posted on the PYM website. Hospitality is being offered on Friday nights to IM members and attenders who travel from afar to the Saturday Interim Meetings that begin in January. IM is now to be held the 2nd Saturday of each month through June 2009, in the hopes of attracting Friends who could not make it to Thursday night meetings. Arthur then addressed the current financial situation for FY 2009 and stressed the importance of contributions to cover expected investment losses.

Burlington-Princeton Minutes on Quaker Process: Friends of Princeton MM united in a concern that "our YM has drifted away from the practice of rightly ordered Quaker Process in our Annual Sessions. Seeking discernment from the corporate body of the YM has been supplanted by extended opportunities for fellowship. Business and decisions which affect all of us are given little space on the YM session agendas, and appear to many of us to be decided in advance of the meetings, and quickly pushed through a brief time on a crowded agenda." After a lengthy discussion, it was decided that the IM Clerk and the Standing Committee Clerks would meet and discern whether or not a Called Session will be necessary.

Heeding God's Call: Proposed Minute on Handgun Violence Prevention in the Commonwealth of Pa. "PYM supports the witness for handgun violence prevention planned for January 17, 2009 with its emphasis on persuading gun shops owners to adopt the 'responsible firearms retailer partnership: a 10-point voluntary code' for sale of handguns. PYM asks the Pennsylvania State House of Representatives (its leadership and Judiciary Committee), the State Senate (and its leadership), and the Governor of the Commonwealth of Pennsylvania, to enact and sign legislation to reduce handgun violence in the Commonwealth of Pennsylvania. This legislation is commonly known as the Lost or Stolen Reporting Requirement and the One Handgun a Month bills." PYM encourages Monthly and Quarterly Meetings to support and to participate in the Saturday, January 17 witness for gun violence protection. More info is available on the PYM website.

Annual Fund Report: Wright Horne, Associate Secretary for Advancement and Communications echoed Arthur Larrabee's concerns for continuing contributions. Due to the economic climate, the Annual Fund is lagging behind last year's. Wright asked IM members to convey a sense of measured urgency to our MMs in order to maintain programs and services at their current levels.
