**Approval of minutes** from Ninth Month business meeting-Approved

### **Clerk's Desk- Molly Brian**

Membership requests were received from Jonathan Slocum and Steven Meixner and referred to Pastoral Care Committee.

Recent memorials leave holes in our hearts and on our benches. Friends worked well together in community to create these services and share with the attendees how Quakers touch God. Our silences in the past few weeks at the times of loss and in anticipation of the services felt heavy. This week the Meeting seems to be moving on in its grief and was happy to see Candace present in her usual seat. The sound system was really helpful so all could be heard. We may wish to install such a system in our meeting houses. (Property and Grounds is working on this.) Talbot hospice also offers help with grief. We take turns during our lives comforting each other. We continue to remember these and others we've lost, which is part of the loving people we are.

### **Treasurer's Report** First Quarter 2019/2020 fiscal year- *Cynthia Quast*- Approved

Member contributions were over \$8,500 or 16% of our annual budget. Attender contributions total over \$1,100 or 18% of budget. Total income was over \$11,500 or 17.6% of budget. Expenses were just over \$19,900 or 30% of budget. Net Income year-to-date was minus \$8,392.

On Balance Sheet as of 9/30/19, we had over \$51,900 in operating checking account and about \$68,500 in Invested operating funds at Friends Fiduciary.

Compared to last year, Member contributions are up almost \$5,600 and our total income is up by almost \$4,500. Our expenses are down year-to-date by over \$1,500.

### **Property and Grounds Annual Report** – *Ben Tilghman/Priscilla Morris*- Accepted

In fiscal year 2018-2019 Property and Grounds ended the year with a bit of a surplus. As is the case this year, this most often is the result of limited snowfall, no hurricanes, no profound mechanical failures and so on. While it is tempting to take credit for the budget surplus, P&G in a bit more pragmatic. In fiscal year 2019-2020 we have several projects to complete, all fairly major, and funding will be a bit more restrictive.

In 2019 we completed several small tasks, such as trimming the rhododendron (aggressively) away from the Brick Meeting house in the hope that it would help to reduce the moisture problem on the south east wall (it did not), installed an industrial grade outdoor light on the brick meeting house, and, with profound thanks to Clay, assisted with Little Spices and first day school. We spent a fair amount of time discussing the strategic plan, P&G's role in the implementation, and our relationship to the Long Range Planning (LRP) committee. We came to the conclusion that many of the items on the Long Range Plan such as additional parking and so on really fall within the routine duties of P&G. At this point I feel we have a good understanding of the balance between the role of P&G and the LRP, particularly since I seem to be the clerk of both.

For the coming year we have several significant projects underway already. We are in touch with a craftsman who can rebuild the exterior doors to the Brick Meeting House (thanks to John Hawkinson), and a mason who will rebuild the pillar on Washington Street, inserting the old marble sign with an updated time on it (thanks to Bob Day). Joan Wetmore contracted with a

certified home inspector to do a detailed assessment of Clay's house, and Bill Lane has arranged with a contractor to begin the work needed to correct the deficiencies noted in the inspection, none of which were deemed major. We have arranged for a tree service to do some general pruning around Clay's house and generally clean up the lane to Washington Street. And, of course, we will continue to address the routine tasks needed to maintain the property and grounds, such as repairing windows in the Old Meeting House.

The native planting of our east border next to the apartments is an on going multi-year project started by Rob Wieland, currently tended by Priscilla Morris. In 2019 thanks are due to Dona Source, Stephanie French, Marie Leonard, Owen Bond and Tenny Sener for help with planting, watering, and deer abatement. With letters of support from the Trustees, the Town of Easton's stream restoration grant succeeded and construction work will occur in 2020, most likely in the summer. The town will be adding native plants in the restored stream area.

P&G would like to make special mention of the Peace Pole project. Through Testimonies and Concerns we were asked to arrange to have a Piece Pole installed in honor and memory of Ralph Young. We have located a highly skilled woodworker (Jennifer Kuhn) at the Maritime Museum who has agreed to make the Pole for us, and will begin work in early November. John Hawkinson and Winslow Womack, both of whom have worked with Jennifer will be assisting with the project. P&G will fund the project, but is happy to accept donations for the construction and installation of the pole if Friends are so moved. We anticipate the cost to be in the vicinity of \$1,000.00

The funding source for some of the above projects, aside of the Peace Pole, has yet to be clarified, hence the uncertainty of the 2019-2020 budget. The Trustees have offered to help with the repairs to Clay's house to the extent that they are determined to be capital investment, but so far most of what we are planning appears to be more like routine upkeep and expense. I do not anticipate that we have a problem, however; P&G's working relationship with the Trustees is very good.

Friends are reminded that fall clean up day is December 7.

P&G routinely meets the first Thursday of the month at 4:30 in the Common Room. All Friends are most welcome to attend.

A Friend noted that Ben Tilghman uses his own time and heavy equipment to care for the property, doing task that otherwise would be expenses.

A Friend asked if a gutter could be put above the Brick Meeting House door by the ramp. Historically appropriate Brick Meeting House maintenance, given the 19<sup>th</sup> century construction, is being considered.

The town of Easton killed invasive vines near the stream and will be grading the stream wider and replanting native species.

### **First Day School Update**-Amy Owsley

Little Spices for caregivers and 2-3 year olds has returned. Emily Wilhelm teaches. Meeting Friday mornings 9:30-11:30, the program covers Quaker testimonies in an outdoor setting. The full budget for the program for 6 weeks is \$700. We receive \$800-900 from attending families (\$90 per session), so the program is revenue positive. Parents sign liability forms and are responsible for their children. November 8<sup>th</sup> will be a potluck around the Community testimony. This is outreach through the First Day School.

### **Nominating Committee Report**-Connie Crow

Nominating is looking at committees that might need help as well as individuals who are doing a lot more than other people. The plan is to try to even things out. Needs include a liaison to Peace group, and additional help for Pastoral Care and Outreach. A list will be available at the November meeting for business. That draft will be revised and approved in December. Please contact Connie Crow, Nancy Robbins, or Bill Lane about your participation on committees for the coming year.

## **First Day School**



Autumn has finally found First Day School! We began our October lessons with a nature adventure among the newly fallen leaves and chilly fall breezes, with our camp teacher, Kristen Hanlon. We had a boisterous group of 16 children engaged in a contemplative nature walk and project. The following week, Jeanne Halpin led her “Queries and Reflections” with a further investigation of our Quaker Testimony of PEACE - a series which will culminate in the children’s participation in Easton’s Christmas Parade on their Peace Float! Later in the month, Susan enraptured the children with her storytelling of a Godly Play which began to familiarize the children with Bible stories that inform our faith. The kids were overjoyed to finally roll out the "Desert Box", which acts as our very own square of desert right there in the Brick

Meetinghouse, to tell the story of Abraham and Sarah (called the “Great Family”).

Meanwhile, centered in the area near Annie’s Cottage, First Day School has organized another session of our popular Little SPICES program for little ones (3 and under) and their caregivers. Led by a new teacher (Emily Wilhelm who has been a SPICES participant from the start), this fall’s series last for 6 weeks - each session focused on discussion of one of our Quaker Testimonies.
