Those attending from Third Haven were Molly Brian, Marie Leonard, Steven Meixner and John Schreiner. Approximately 23 members & attenders from respective meetings introduced themselves (Camden Friends Meeting, Lewes Worship Group, Third Haven Friends Meeting and Wicomico River Friends Meeting). We enjoyed hospitality & fellowship prior to Meeting for Worship and afterwards Jim Laity, Clerk, (WRFM) gathered many for Worship Sharing where we considered queries on Listening, Trusting and Acting. There were many inspiring and hopeful messages. Then a delicious potluck lunch was served. Next quarterly meeting will be in January in Camden.

**Property & Grounds Annual Report- Larny Claggett and Priscilla Morris Accepted**

The operating guidelines of the property and grounds committee are: Preserve the meetinghouses. Maintain buildings in good repair and grounds in good order. Allow the common room to serve our needs. Keep grounds natural and healthy. To do this the committee relies on: The meeting for funding. We use roughly half of the meeting's budget. P&G budget is \$34,000 and change. Our caretaker, Clay Owens, to do the bulk of the day-to-day work. Meeting committees and folks to employ their time and talents (e.g., clean-up days). Outside contractors.

This year some of the special efforts have been to maintain and expand the native plants along our eastern and northern property lines, repair and paint the entry area of the brick meetinghouse, paint (partially) Annie's cottage, improve grading and drainage around the old meetinghouse, and work with the consultants and contractors on window repairs, ventilation, and siding repairs to the old meetinghouse.

Members of the property and grounds committee have been Priscilla Bond Sener (co-clerk), Robert Gladney, John Hawkinson, Bill Lane, Matt Moore, Clay Owens, Nancy Robbins, Bob Wack, Winslow Womack, and Larny Claggett (co-clerk). Due to personal reasons, Bob Wack and John Hawkinson have stepped down.

**Planning Committee Update- Tom Corl**

Per the documents published in the Meeting email announcements, today at the meeting for business, on behalf of the Planning Committee (PC), we request:

1. approval of the master planning proposal from Milner, and authority to sign and proceed with implementation; **Approved**
2. approval of the allocation of funds from the Meeting's financial reserves to pay for part of the costs. Trustees will pay \$35K toward this agreement. **Approved.**

Joshua indicates that additional reimbursable expenses should be around \$1200. That brings the estimated total to roughly \$70,000.

Responses to questions:

Duration may be 6 months from start date. We will contact Milner and arrange to proceed.

A formal master plan report to be used for fund raising would be an added expense. We will be getting adequate deliverables for our needs. General idea of costs for the building project will be available, but not precise professionally done cost estimates.

3. We need to establish a fund-raising apparatus. Part of the planning process will be determining priorities, sequencing and fund-raising. Fund raising will take efforts of many people.

4. Community access, openness, welcoming and security for the property require consideration. Clerks are planning a worship sharing on this topic. This includes considering use of the buildings by those outside our faith community.

Budget and Finance notes annual giving supports our annual budget of about \$70K per year. Contributions to the Building Fund are in excess of annual giving. Frugality of our committees and generosity of members help us stay under budget.

**Third Haven Art Show & Sale Proposal** was made to move forward with the planning of the art show and sale again this year, with work by Third Haven members, attenders, family & friends to benefit the Meeting. **Approved**

Invitations to participate will be sent to Asbury Methodist artists, Talbot Historical Society and be included in upcoming Email Announcements. A group of volunteers have started to form with the task of planning the event, much like last year. Volunteers may be needed to help with parking and visitor's questions about Third Haven Friends. No conflict was seen with the proposed date, which is also Fall Clean-Up Day. The proposal for the Art Show & Sale was approved.

### **Saints Peter and Paul Visit**

Recently students from the seventh grade of St. Peter and Paul middle school visited Third Haven. This class is studying Talbot County history. They were welcomed by Molly Brian, Tom Corl, Marsie Hawkinson and Dee Rein. Teachers reminded them that Third Haven is a sacred space and the Old Meeting House to be treated as a church. With suitable reverence the young people filed in and took their seats in the Old Meeting House. Clerk Molly Brian began by inviting them to imagine how it would be to be their age in the year 1684, traveling to rare Monthly Meetings by boat up the Tred Avon, walking or on horseback or buggy to enjoy the friendship of people their own ages. She explained Quaker beliefs in simplicity, peace, integrity, community, equality and stewardship as well as the belief that there is that of God in every man. To complete the Quaker experience students were asked to join in a brief time of silent worship. The grounds of Third Haven were then available for exploration. Students searched the graveyard for the headstones of a 16-year-old and 82-year-old. Some found the overturned earth and recently placed headstone of Joyce Zeigler and asked about her recent death. They were struck by how recent it was and interested in hearing about Joyce and her previously deceased husband Frank. During this visit Third Haven Quakers came alive for some very lively young people.
